3. Student Voices – 10 mins	a. Students' thoughts arising from GP workgroup meetings Corey mentioned there were student concerns about if schedule of courses for fall was going to change moving forward. Evening student's also asking if we go back on campus, will we be offering on-line evening classes.	

4. Guided Pathways Updates and Discussion – 25 mins

a. Operational Budget for Yr 5 — Seb

An Excel spreadsheet on Budget was shared. We currently are trying to prepare for next year as we are getting proposals in. The Guided Pathways money was split into five years from state. We are currently on year five. There is some money left over, as we normally budget more than we spend. We do this as we want to make sure we set aside enough money for our committee to be able to operate. Spreadsheet is self-explanatory. All adds up to \$245, 000.00. Focus on the Anticipated column. Discussion on proposal to bring faculty reps across campus committees. Looking at who is most in need of extra representation. Also looking at next year's operating costs.

b. Proposals—Update from Review Team — Debbie

There were some challenges using the rubric. We found a discrepancy on proposals; some can have high ranking but low rubric points. We had a sub-group of our work group revise the rubric. With the revisions we are calling the first proposals, round one. There will be round two if there is money left over. Debbie shared Excel worksheet on requests and ranking of the six proposals. There was a question of a need to know about sustainability when they make their proposals, as we don't know if this is going to require ongoing costs. Discussion to consider Classified Overtime on proposals, as some items might require work to be done from our Classified Professionals.

8. Presentations – 15 mins	1. GP Data Dashboard — Phil Phil discussed GP Data Dashboard and shared the data with committee. There was an issue with student's logging in. We are working with IT to make it accessible. The link to access Dashboard is here; https://tableau.vcccd.edu/views/GuidedPathwaysDashboard Phil went over the data with group. He went on demonstrating the different tabs and how to select a year and the data pops up. The Dashboard shows; subject/title, amount of students, percentages, average VC Units. If you want to see different demographics scroll down and it gives you an overview at the CMC level. Major demographics tab you can see CMC Level to Major Level. MC built something similar. Committee discussed data from spreadsheet.	

A question came up if there was data on part-time vs. full time. At the moment Dashboard does not have that data, but we can think about adding. Another question that came up was, if there is a way to find out if a student is considered part-time, is it because the student is taking courses at different campuses. The Dashboard only shows VC courses, we can add district units. Reviewed data on grades from three (3) year and six (6) year timeframe. Completion rates vary by major and CMC. Discussion on majors coming from Banner and we really cannot rely on it. If student changes major, Banner might not catch the change, which in turn doesn't give us clean clear data. Corey mentioned one of the reasons why students don't change their majors, is because they are not informed. We want to have students have better information to be able to choose right majors. Are we giving students an opportunity to have the right tools so they don't have to make major changes? Working with different groups-working with career center to look at how to help students or give them the right tools. The plan is to have this available for public to view. - CMC Success Team could
 - Look at their program maps for completion (Simplify)
 - Determine what information needs to be on each program website (Simplify)
 - o Identify Career and Major exploration opportunities for their CMC (Access the Path)
 - o Identify key first semester courses that include career and major exploration within the course for each CMC or collaborate with ENGL V01A to develop CMC centric assignments (Access the Path)
 - o Identify/Review strategies for supports for Math/English/ESL and students who may be at higher risk of not succeeding/ending up on academic probation (Access the Path (although this feels like something that goes into both Implement Support as well)
 - o Identify strategies to collaborate with K-12 partners within each CMC (Access the Path)
 - identify key services for their CMC (Implement support)
 - Leverage district wide support for enhancing DegreeWorks and Starfish to support students (Implement support)
 - o Identify make up of personnel/staffing for each CMC including Faculty, Counselors, Classified Professionals, Administrative Leads, Student Peer Leaders etc (Implement Support)
 - Develop a 2-year course offering plan for each CMC working with Institutional research (Implement Support)
 - o identify key co-curricular activities for their CMC including internships, placements, etc (Learning)
 - Consider development of e-portfolio or similar for students to display work for further education or job opportunities (Learning)

Goals from SOAA

- o Determine final draft of meta majors/Career and Major Pathway composition and obtain approval from constituency groups.
 - Related to 1. Begin Marketing these names
- o Determine where Program Maps will "live". We need to get some consensus as a college if we are going to use Bakersfield's Program Mapper software model, develop our own, or use static PDFs to make available to students via the redesigned website.
- Complete Program Maps for all programs with consistency and obtain approval from constituency groups.
- Begin development of Co-curricular maps.
- o Make program maps widely available to students. (This is really the same as #2, but it's important enough to state twice).
- o Increase the number of 2-year course cycles so that at least 50 percent of our programs have this available for review.
- o Examine the implication and impact of how VC has implemented changes to Math and English assessment per AB705 with appropriate data.
- o Inquire with departments the feasibility of developing gateway courses or enhancing Introductory courses for 1st semester students. (Great example is ENGR V01 that we can potentially showcase in Spring retreat).
- o Review the process for New Students from Application to Registration to First semester entry. Much of this is already happening, but not sure it's being brought back to the GP group consistently. Is this where MYPATH fits in and what is going on with MYPATH from a district level?
- Work with high schools that offer Career Exploration (Get Focused-Stay Focused) curriculum to ensure smooth transition for students who have completed the curriculum.
- Market technology such as STARFISH, DegreeWorks to all students and staff.

- Monitor Starfish Early Alert implementation and provide additional training/support as needed. This probably is occurring within the Academic Standing Task Force, but should be something we ask about regularly.
- o Increase awareness of services and activities via the Career Center.
- o Determine feasibility of forming a Task-Force to address part-time/evening students.
- o Increase campus in-reach for financial aid awareness.
- o Form a regularly district meeting with folks from OC and MC GP teams.
