## List of Programs that Do Not Meet "No SLO, No Dough" Criteria

On February $24^{\text {th }}$, 2014 the College Planning Council began discussing a "No SLO, No Dough" policy with regard to program review. The purpose of this policy is to ensure that programs that are not actively participating in the SLO/SUO process do not receive funds for program review resource requests. Programs must meet each of the criteria in the rubric below in order to be eligible to receive funding for program review resource requests. Exceptions will be granted only in rare, justifiable cases.
