IV. Informational Items

- a. Curriculum Committee Update—MB gives update. Tech Review Chair is a facilitator position (40% release). He is “cautiously optimistic that they will have someone in place by fall. ACCJC SLO Update: the metrics of accounting fro CSLOS have changed to target deadline of Oct. 1<sup>st</sup> for decision (in/out) for non-offered courses (150 not offered recently to meet CSLO/ACCJC requirements). All programs submitted to state have been approved.

- Motion to reorder agenda by MB; 2<sup>nd</sup> by RF. Approved unanimously.
- c. 2017-2023 Educational Master Plan (2nd reading)—P. Briggs notes that some data still to be updated. Motion by AH; 2<sup>nd</sup> by RF. Approved unanimously.
  - f. Program review process (1st reading) -Philip Briggs is here and he walks senators through this process. Discussion follows. PHS thinks since we are low attendance this meeting (barely at quorum), we should not approve as to 1<sup>st</sup> & 2<sup>nd</sup>. Senators concur. Motion by PHS as to first reading; 2<sup>nd</sup> by HD: Motion to approve as to 1<sup>st</sup> reading with the addition that by 5/15 every program that shall be expected to complete a program review the following year, a final list shall be established. AH would like to have the rubric back (i.e. how it was applied). Senators concur. Vote: unanimous.
  - h. IEPI goals -Philip Briggs is here to speak to this as well. He passes out a handout with graphs of these metrics. Senators discuss target goals. Motion to approve by AH; 2<sup>nd</sup> by PHS. Vote: unanimous.
  - b. Resolution Re: Tutoring Center, Library & Assessment Center (1st & 2nd Reading) -PHS speaks to this. Movement to replace reading room &/or tutoring center with an assessment center. His resolution is asking for them not to repurpose the reading room and also, don't assume you know the best use of a space—talk to the people whose space it is. Motion by CMC; 2<sup>nd</sup> by BW. Vote: unanimous.

- e. 2016-2019 District Strategic Plan -Motion by PHS; 2<sup>nd</sup> by AH. Vote unanimous as to 1<sup>st</sup> reading and 2<sup>nd</sup> at next reading.
- i. Approve CTE liaison—Deanna Hall wants to be the CTE liason. This is now an official Motion by PHS; 2<sup>nd</sup> by RF for rest of this year and 2017/2018 school year.
