REVIEW COMMITTEE'S CHARGE BASED ON MAKING DECISIONS HANDBOOK	Gloria passed out a section of the "Making Decisions at Ventura College Handbook," specifically pages 5-20, that addressed Campus Committees (Governance, Operational and Advisory). She expressed concerns about the activities undertaken by the President's workgroup on the "Making Decisions" handbook that is reviewing our campus' committee structures and decision-making processes at VC, noting specifically her belief that this group could be recommending changes to the charge and membership of various campus committees, including this one. She also pointed out some discrepancies in our structure vs. our membership, noting that we do not have a Matriculation Coordinator to act as chair. Discussion followed. Gloria asked that this item be brought back to the next meeting for continued discussion; Susan said she would follow up on the process being followed by the "Decision-Making" review group, and also noted that this committee's status as an "advisory" committee may no longer be required by statute under 3SP.
