#### **WELCOME CENTER CONTACTS - OCTOBER 2012 TO JANUARY 2013**

# ■ <u>SUMMARY</u>

This report presents data associated with individuals who received services from the Ventura College **Welcome Center (WC)** between **October 1, 2012** and **January 31, 2013**. The table below provides highlights of the study. Detailed data are presented in the sections that follow.


#### SARS-GRID

When a student physically **visits** the Welcome Center **or speaks** to Welcome Center staff by telephone, the student's contact data are entered into **SARS–GRID**. Contact data include Individual's Full Name, Identification Number (preferably VCCCD Student ID), Age, Reason for the Contact, and Date of the Contact.

#### • Reason Codes

Reason Codes are used to record services provided to individuals who have contacted the **WC**. There are **seven** Reason Codes and for each WC contact, multiple Reason Codes may be used. An example would be a student who calls the Welcome Center to inquire about the way to drop a class and for help in resetting her Student Portal password. In this case, three Reason Codes would be used: Phone, Add/Drop, and Reset. Descriptions of Reason Codes appear below the chart.

From **October 2012** to **January 2013**, there were a total of **3,563** WC Reason Codes entered into SARS–GRID. Since multiple Reason Codes can be entered for each contact, the number of WC contacts is **less** than **3,563**. In the chart that follows, the percentage distribution of Reason Codes are graphically displayed. The most frequent reasons that individuals contacted the WC were related to obtaining general information (**General – 18%**) or portal issues (**Portal – 18%**) followed by help with resetting Student Portal passwords (**Reset – 17%**).



#### • Individual Contacts by Month


The total number of WC Reason Codes recorded during the October 2012 – January 2013 period was **3,563** (see previous section for details). These **3,563** Reason Codes were associated with **2,997 individual** contacts. (SARS–GRID uses <u>unique</u> History Codes to connect <u>all</u> Reason Codes associated with a specific contact – counting History Codes, yields the number of individual contacts.

In the chart below, the percentage distribution of WC contacts are graphically portrayed. January was the month with the most contacts (1,220 or 41%) followed by November with 731 or 24%.



## • Unduplicated Individuals by Month

The total number of contacts by month was **2,997** (see previous section). Many of those **2,997** contacts were <u>multiple</u> visits/calls to the WC by the same individual. The total number of <u>unduplicated</u> individuals contacting the WC <u>each month</u> was **2,391**. Again, January and November had the highest contact rates.

#### DEMOGRAPHICS

#### • Unduplicated Individuals over the Four Month Period

The total number of <u>unduplicated</u> individuals who received services from the WC <u>each month</u> between October 2012 and January 2013 was **2,391** (see previous section). Many of these individuals were in contact with the Welcome Center in <u>two</u> or <u>more</u> months. For the **four** month period, the <u>unduplicated</u> number of individuals receiving services through the Welcome Center is **2,045**.

## • Matching Student IDs to Banner Records

To obtain demographic information regarding these **2,045** individuals, their VCCCD Student ID (or SSN) had to be matched to a record in the Banner System using the "Admission Applications View" or the "Student Term View." Of the **2,045** individuals, **1,771** were matched to a Banner record. For the reasons listed below, the other **274** (**13.4%**) individuals were not able to be matched to a Banner record.

- (1) **90** of the individuals did not have a VCCCD Student ID or an SSN:
  - a. SSNs were entered in SARS-GRID:


When SSNs were used in lieu of a VCCCD Student ID, the IR Office attempted to match the SSNs to the SSN field in Banner and thereby obtain demographic data for these individuals (47 SSNs were matched Banner records).

- b. No VCCCD Student ID or SSN:
  - For individuals without a VCCCD Student ID or SSN, WC staff pressed the F7 key and SARS–GRID assigned a unique nine-character code (starting with SG0) to each of the individuals.
- (2) **184** of VCCCD Student IDs or SSNs were unable to be matched to a Banner record because of <u>one</u> of the following reasons:
  - a. Individual's VCCCD Application was filed before spring 2013
  - b. Individual wasn't enrolled at VC, MC, or OC in spring 2012, fall 2012, or spring 2013
  - c. Individual's VCCCD Student ID was entered incorrectly

Note: There were instances where individuals had multiple SARS–GRID records <u>and</u> the records had different ID Numbers, e.g., one record with a Student ID and one record with an SG0 ID.

#### • Gender

As explained above, **1,771** individuals were matched to Banner records. Of these 1,771 individuals, females account for **51.2%** and males account for **47.7%** (see chart below).






## • Ethnicity

The majority of individuals receiving services from the Welcome Center were Hispanic (53.4%) with Whites a distant second at 33.4% (see chart below). Last fall (2012), Hispanic students accounted for 53.6% of the student body and Whites accounted for 33.8%.



#### • Age


Individuals in the traditional freshman/sophomore age range (17–19 years of age) accounted for **27.1%** of persons contacting the WC. Individuals in the 20 - 24 year age group accounted for **27.2%** of persons who received services from the WC, and 25 - 29 year olds were in third place at **13.6%**.

## • City of Residence

Almost **94**% of individuals receiving services at the Welcome Center between October 2012 and January 2013 resided in Ventura County (see data table below). Ventura is the city with the highest percentage of individuals contacting the WC (**37.4**%) followed by Oxnard at **28.1**% and Santa Paula at **8.5**%. The chart depicts percentages for the eight cities with the most individuals contacting the WC.



## • Term First Enrolled at a VCCCD College

Most (91.3%) of the individuals who contacted the Welcome Center between October 2012 and January 2013 were current or former students, only 9.3% were never enrolled at a VCCCD college.

For over **39%** of the individuals, their first term enrolled in the VCCCD was between summer 2011 and spring 2013 (see table below).
