SPRING 2016 - STUDENT SURVEY REGARDING A SMOKE-FREE CAMPUS

■ BACKGROUND

The Ventura College Student Health Center provides medical services to VC students. Mary Jones, Coordinator of the Student Health Center, is also the co-chair of the Ventura College Safety and Wellness Work Group, which is recommending that Ventura College become a **completely smoke-free** campus. Currently, smoking tobacco products is permitted **only** in college parking lots. Under the smoke-free recommendation, smoking would be **prohibited everywhere** on campus.

To determine whether students support the proposal to make Ventura College a completely smoke-free campus, a survey was designed by Mary Jones and Michael Callahan, VC Institutional Researcher. The survey was anonymous and consisted of three closed-end questions and a comments section. After the survey questions were finalized, the survey was created in SurveyMonkey and a hyperlink to the survey was emailed to spring 2016 Ventura College students on April 28th. The survey collector was closed on May 17th, 19 days after the survey link was emailed to students.

■ <u>SURVEY POPULATION AND RESPONSE RATE</u>

Invitations to participate in the survey were sent to **12,801** spring 2016 Ventura College students. The table below indicates the method used to obtain the survey population.

A total of 1,158 surveys were completed, for a response rate of 9.6% $[(1,158 \pm 12,081) \times 100]$.

Statistically, a minimum of **372** respondents would be necessary to meet generally accepted educational research standards (95% confidence level and $\pm .05$ confidence interval) for a survey population of **12,081**.

With 1,158 survey respondents, there is a high probability (99% certainty) that response percentages are within ± 3.6 percentage points of that which would be expected of the entire survey population.



Are you in favor of VC becoming a completely smoke-free campus?



Distribution of Survey Respondents



Cross Tabulation of Question 1 and Question 3

In the contingency table below, respondents' answers to Question 1 are compared to their answers to Question 3.

It is interesting to note that **6%** (**41**) of students who are in **favor** of a smoke-free campus **are** vapers, smokers, or users of other tobacco products.

Conversely, **54%** (**210**) of students who are <u>not</u> in **favor** of a smoke-free campus are <u>not</u> vapers, smokers, or users of other tobacco products.
