IN THE NEWS...

Dr. Jory Hadsell, Chief Academic Affairs Officer, has been named the next OEI Executive Director!

Last week, Joseph Moreau, Vice Chancellor of Vice Chancellor of Technology, Foothill-De Anza Community College District, and our OEI Executive Sponsor, announced that he has selected Dr. Jory Hadsell as our next Executive Director, after our amazing Pat James retires in a little over two months.

"Jory is widely known and respected as a visionary leader, a remarkable consensus builder, and someone deeply dedicated to continuing OEI's mission of making the well-being of students our top priority," wrote Joe in his announcement. As much as we will miss Pat and greatly appreciate her outstanding leadership these past almost three years, the OEI staff agrees with Joe's assessment and are "confident he [Jory] will continue to lead OEI and our colleagues throughout the state to the next level of excellence in supporting our students and faculty in online instruction and student services."

COURSE EXCHANGE IMPLEMENTATION

Version 1 of the Course Exchange will be deployed to the production environment on October 25th. The Course Exchange development team has been working extremely hard to meet this deadline. Please join me in congratulating our developers on this achievement!

Starting next week we will begin to the process of handing off the Course Exchange Pilot Environment for User Acceptance Testing (UAT) to colleges where we have been completed functional testing of the Course Exchange. To date functional testing is complete at Butte, Coastline, Foothill, Fresno, and Lake Tahoe. During the UAT testing period, Colleges will have the opportunity to test the Course Exchange processes with functional users at their respective campus, prior to making a decision to go live with the Exchange. As well, we will continue to work with the remaining colleges to complete functional testing in preparation for a UAT hand-off.

We have also been working with each of the Full Launch colleges to prepare their production environment in preparation for a go-live decision. Much of this work has occurred behind the scenes with the IT departments completing setup tasks. In addition to the IT setup, we have been scheduling Admin Interface setup meetings where we will walk an admin user at each college through the process of setting up courses in the Course Exchange, these meetings will begin next week on

October 26th. Once UAT and admin setup tasks are complete, we expect colleges to go live on the Course Exchange. Dates for the go-live will vary depending upon the unique needs at each of our Full Launch pilot colleges.

NETTUTOR ONLINE TUTORING & WORLDWIDEWHITEBOARD

As SPOCs, IT personnel, and tutoring center coordinators change, colleges move to Canvas, and more faculty start using NetTutor and the WorldWideWhiteboard (WWWB), LSI (provider of NetTutor and WWWB) will restart the implementation calls with each college's stakeholders. Please expect an email from Chris Bergeron, Chuck Myers or another LSI person to set up this meeting.
