Public comment about whether curriculum must always be written by faculty. Dr. Keebler answers: if instruction is non-credit or not for credit (I.e. like community service classes used to be offered), then it can be written outside the faculty/curriculum committee process. This will be a future agenda item.

 - a. President Keebler: Faculty should put in work orders to have bookcases or other heavier furniture secured to the walls of their offices. Dr. Keebler is here and checks in with the senators about some of the challenges facing our campus (communication, HR, safety) that he is trying to carry forward and have addressed by the incoming president.
 - b. Distance Education Committee recommendation on OEI Rubric. AH: Rubric is a standard for the courses in this exchange. DE Committee is recommending that all instructors teaching online use this rubric as a best-practice.
 - c. Guided Pathways Update (Colleen): Plan was submitted to the state. PM: Wants to make sure that basic skills are still available to students as all students don't want to transfer. LM: This relates to AB705. Announces to senators about the flex day activity (end of April) that will have a presentation from Bakersfield College about this.

d. CTE liaison report (Deanna Hall): Updates the senators re: recent developments in CTE. 8 of our programs received recognition/awards; recent hiring of classified staff, etc. Also talks a bit about the proposed California Community College Online College. e. Forums for Presidential finalists update: LM updates senators about this event. It will be 5/11, time TBD, probably in ASC. Individuals who are willing to help plan this: Heather Aguillar, Laura Wojach, Deanna Hall, Executive Council. **The faculty need to be queried about what—if any—questions they would like to ask of the candidates in this forum. Candidate bios should be distributed along with this email. Phillip Briggs says** he can create an online forum where individuals can post questions—senators like this idea.

a. Approval minutes (3/15/2018): Motion by LW; 2^{nd} by SB. Discussion: none. Vote: unanimous with one abstention.

b. Great Teachers Seminar: LW motions to approve Ventura College Academic Senate Great Teachers Seminar Procedures. LM gives senators a summary of why these procedures are necessary. Senators discuss this. JW: Would prefer to see a process that puts full-time & adjunct faculty on an equal footing. SB: Not comfortable with a first-come first serve process. CL: Agrees that the tenure process individuals should be given preference since those are the individuals we want to nurture. BH: Suggests giving priority (to adjuncts) based on longevity. Senators discuss how to determine longevity. Senators want to further discuss this but we must agree on a process for this year. Here will be this year's process: First non-tenured (in the process), then tenured faculty and adjuncts based on longevity at VC. Longevity in each step. Vote: unanimous.
