OEI Update	<p>Ally is currently in the DE Faculty Hub for faculty who would like to see</p> <p>Ryan and Asher ask to have it turned on; Ally will be turned on for everyone eventually, by law</p> <p>OEI testing exchange which will enable students to enroll at multiple schools from a single screen without paying additional fees</p> <ul style="list-style-type: none">VC hoping to be part of the exchange test group for next semester284 registrations through OEI for Fall 2018 <p>53 colleges now listed on cvc.edu (Finish Faster) – students can find all online classes that meet IGETC certification for transferring</p> <ul style="list-style-type: none">ADTs listed that can be completed online (major prep courses) <p>6% of VC courses presently OEI aligned – goal is 20%</p> <ul style="list-style-type: none">170 total courses approved for OEI in whole exchange (5-6 at VC)The challenge – where to find the time to put course through? <p>POCR is a new online peer review process put forward by OEI. The first POCR training is coming this semester and Sharon will be participating; will take approximately 40 hours.
