The current VC Strategic Plan spans 2017-2020 so we have until 2020 to reach the goal of having 30% of the schedule being DE classes. Need more support for marketing of DE at VC and district-wide – VC currently has only one marketing person who is stretched over multiple projects. Conduct student survey to determine demand for FT instructors being on campus 4 days a week? Possible solutions: Always have a FT representative from each department on campus Create spaces for faculty to interact while they are on campus Any changes will be made possible by continuing to educate the executive administration on DE.
