Item 1. Statement of Program Goals and Objectives

The Associate in Science in Agriculture Business for Transfer Degree prepares students for transferring to a California State University in Agribusiness. This program allows students to complete courses that comprise the core undergraduate work required at a California State University (CSU). Graduates from a CSU will be prepared to enter the growing agribusiness industry, which provides the products and services related to production, processing, marketing, and distribution of food products. Professionals in this industry bring strengths from the integration of business, science, and technology. This program combines core concepts of business with the additional skills and knowledge necessary to meet the needs and challenges of agricultural businesses. Management, decision-making, communication, and technology skills will allow students to be prepared for careers in agricultural sales, marketing, finance, accounting, production, and management. Graduates are valuable employees in the agricultural business industry and career opportunities are expected to be strong.

Program Student Learning Outcomes

By the completion of the degree the student will be able to:

- 1. Identify, evaluate, and apply business and economic principles, including ethical behavior and social responsibility, to agricultural business operations.
- 2. Apply basic accounting principles to aid in financial decision-making in agricultural businesses.
- 3. Demonstrate interpersonal and organizational communication skills and the application of sales techniques.
- 4. Demonstrate competency in using computer applications to complete agricultural business projects.
- 5. Apply the principles of plant and soil science to successful production in an agricultural business.

Item 2. Catalog Description

The Associate in Science in Agriculture Business for Transfer is designed to prepare students to develop the core business skills necessary to meet the needs and challenges of agricultural businesses. Students integrate concepts from business, science, and computer technology and apply them to agricultural business operations. A student graduating with an Associate of Science in Agriculture Business for Transfer may transfer to a California State University to complete a Bachelor's Degree in Agribusiness.

Students who complete an Agribusiness Degree will be prepared for careers in agricultural sales, marketing, finance, accounting, production, and management, as well as general agriculture.

Program Student Learning Outcomes

By the completion of the degree the student will be able to:

- 1. Identify, evaluate, and apply business and economic principles, including ethical behavior and social responsibility, to agricultural business operations.
- 2. Apply basic accounting principles to aid in financial decision-making in agricultural businesses.
- 3. Demonstrate interpersonal and organizational communication skills and the application of sales techniques.
- 4. Demonstrate competency in using computer applications to complete agricultural business projects.
- 5. Apply the principles of plant and soil science to successful production in an agricultural business.

Students must satisfy both of the following requirements in order to earn the Associate in Science in Agribusiness for Transfer degree:

- (1) Completion of 60 semester units or 90 quarter units that are eligible for transfer to the California State University, including both of the following:
 - (A) The Intersegmental General Education Transfer Curriculum (IGETC) or the California State University General Education Breadth Requirements.
 - (B) A minimum of 18 semester units or 27 quarter units in a major or area of emphasis, as determined by the community college district.
- (2) Obtainment of a minimum grade point average of 2.0.

(Career preparation and workplace skills for students with Autism and other unique styles of learning)

Item 1. Program Goals and Objectives

The ICAN certificate is an employment preparation and workplace skills program designed for individuals with Autism, intellectual disabilities, or challenges performing successfully in a workplace setting, but also open to anyone who can benefit. Provide students with the job and workplace skills to enhance their employability and provide value to employers. It will increase access of individuals on the Autism Spectrum and the economic need to train qualified workers blends to meet the needs for the workforce of today. Students will complete these non-credit courses with various assessments documenting their interests, achievement of workplace skills. The ICAN is a truly unique employment preparation program for students with Autism and unique abilities. ICAN is consistent with our community partnerships vision, such as VCOE Boswell School and other Post-Secondary programs serving our community, as well as specific business and industry.

Our students desiring to enter the workforce with Autism and others who have struggled to find, get and keep a job will benefit from this program. The program is designed to provide essential employment skills, including the "soft skills" that are most desired and valued by employers. Students who successfully complete this program may continue their education by taking additional elective courses that lead to a job in the process of defining their career pathway. As part of the program, students will evaluate labor market, as well as their own skills, career interests and aptitudes.

The program targets individuals on the Autism Spectrum and others with traditionally high rates of unemployment, but open to all who have the goal toward reaching competitive employment and working with other community college students.

Program Student Learning Outcomes

The Program Student Learning Outcomes are as follows:

- Students will demonstrate appropriate social skills and optimal workplace behavior.
 - Students will demonstrate appropriate communication skills for the workplace.
- Students will apply computer, personal finance and technological skills for the workplace.

Program Competencies

Upon successful completion of this program, the student will be able to demonstrate the following competencies:

- Identification of personal strengths and interests to determine career pathways and/or career options
- Basic oral and written communication skills essential to the workplace
- Application of basic budget principles to solve vocational problems
- Professionalism and proper workplace behavior
- Basic workplace skills, including planning and organization, decision-making, problem solving, and conflict resolution
- Identification of principles of technology, including mechanical force, mechanical advantage, and technical processes.
- · Appropriate job search skills, including resume writing and interviewing

Program Design

This unique employment preparation program for students with different abilities is consistent with our community partnerships.

Courses in this program are purposely designed to meet the needs of employers, specifically addressing concerns in the areas of "soft skills", communication, basic math, and understanding of computer processes and software. The courses do not replace any current courses but instead enhance them with a vocational lens for this specific population of students.

Certificate of Completion Innovative Cognitive Achievement Network (ICAN)

Career preparation and workplace skills for students with unique abilities design is to provide participants with essential workplace skills to enhance their employability and provide value to local employers.

Students will complete specialized courses with assessments and guidance documenting their achievement of job skills.

The Program Student Learning Outcomes are as follows:

- Students will demonstrate appropriate workplace behavior.
- Students will demonstrate appropriate communication skills for the workplace.
- Students will apply basic mathematical and various computer skills appropriate to the workplace.

There are no pre-requisites or enrollment limitations.

This program does not lead to a specific career pathway, but rather prepares students to be valuable employees who are prepared with the skills employers most desire. As part of the program, students will perform a personal assessment of strengths and interests to assist them in examining potential careers or career laddering. Following completion of this program, students may continue into an educational pathway leading to a Certificate of Achievement or Associates Degree in the career of their choice.

Item 4. Master Planning

The ICAN Certificate has evolved out of the Assistive Technology Training Center (ATTC) has a design and built on the Ventura College campus, designed for several purposes, one of which was to provide computer-training programs in both employability and technological areas. The ATTC provides student-centered, lifelong learning opportunities in a flexible, competency-based delivery system in both credit and non-credit formats. The mission of this center is to address fundamental employability skills that lead to career pathways. The ACT and CDL, as well as the EAC Job seeking strategy classes are the core of this plan.

Ventura College has an Educational Master Plan with five strategic goals. This program links directly to goal #1, which is to continuously improve educational programs and services to meet student, community, and workforce development needs". It also links directly to the Ventura Community College District Strategic Goal #2, which is to "Partner more effectively to meet community needs". As part of that goal, the district

has created objectives, including creating clear pathways for students that lead from education to careers". This program directly serves the needs of students to transition from education to career pathways. To help individuals with disabilities enter sector pathway programs and succeed in them, our aim is to provide a range of supportive services. Currently, the several partners have their own forms of support:

The Department of Rehabilitation, the three community colleges, the adult schools and, of course, the Community Services Department of the County's Human Services Agency (CSD), which, as the region's provider of WIOA Title I, has a number of established ways to help people with disabilities under its supportive services policy. Since June 2016, the AJCC partners have been meeting to collaborate in creating awareness of each entity's unique program needs. This effort involves local and regional WDB efforts to include

the Department of Rehabilitation (DOR), the adult education consortium and the Ventura County Community College District to engage them in efforts to align education and workforce development strategies. By including the DOR in these initiatives, we seek to improve access to current resources and services for individuals with disabilities, including increasing services connecting the disabled with sector 27 pathways to meet employment outcomes for this population. Already these partnerships have helped to create a more cohesive and comprehensive system of AJCC services.

In particular, each of the three community colleges in the region has existing programs to address the needs of students with disabilities:

- Moorpark College has an ACCESS Program to ensure that all Moorpark college classes, activities and facilities are accessible to all qualified students.
- Oxnard College has the EAC (Education Assistance Center), which promotes equal participation in mainstream academic programs through preparatory and skill maintenance courses and offers courses for personal growth.
- <u>Ventura College has Disabled Student Programs and Services (DSP&S/EAC)</u>, which promotes the educational and vocational potential of students with disabilities by supporting each student's integration into mainstream college life.

 A special example of the provision of services to people with disabilities is The Arc of Ventura County, a non-profit agency that works in cooperation.

Courses in this program have a design to meet the needs of community employers, specifically addressing concerns in the areas of "soft skills", communication, basic/vocational math, and understanding of technological processes and equipment. The courses do not replace any current courses but instead supplement them to meet specific student and employer needs. Studies show that employers are seeking specific employability skills in both incumbent workers and new hires, including the following:

- 1. Ability to work in a team structure in solution-focused manner
- 2. Communication skills, both written and verbal, with people inside and outside an organization with confidence in professional manner.
- 3. Problem solving with positive attitude

- 4. Embracing uncomfortable topics and personal management
- 5. Quantitative and analytical skills
- 6. Technical skills related to the targeted job
- 7. Strong sense of work ethic
- 8. Proficiency with assistive computer technology programs
- 9. Leadership skills and teamwork
- 10. Flexibility and adaptability in workplace
- 11. Interpersonal and emotional intelligence skills

Our own advisory board for our COC & CDL / ATTC programs, made up of partners and business, has echoed these same skill requirements. As explained in Item 1, page 1, this program fulfills the needs expressed by employers across all industries.

This program will provide in a non-credit format transformative curriculum, allowing students to take the courses and complete the certificate without the expense of college tuition. This could be just one of many short-term vocational COC offerings that will bridge the college to career divide.

Associate in Science in Early Childhood Education for Transfer

Criteria A: Appropriateness to Mission

Statement of goals and objectives for existing program, including new changes.

Students who complete Child Development courses will be able to apply concepts of child growth and development from Associate in Science in Early Childhood Education for Transfer Degree (Early Childhood Education AS-T) program will develop both the knowledge of the subject matter and professional skills that enable them to work in the Early Education and Family Development fields.

The Associate in Science in Early Childhood Education for Transfer Degree (Early Childhood Education AS-T) is intended for students who plan to complete a bachelor's degree in a similar major at a CSU campus. Students completing the degree are guaranteed admission to the CSU system, but not to a particular campus or major.

A student graduating with an Associate in Science in Early Childhood Education for Transfer Degree may transfer to a four-year institution with the competencies needed to complete a Bachelor's Degree in; Child Development, Family and Consumer Sciences, Human Communication, Human Services, Liberal Studies.

The Child Development courses in the degree pattern are approved as part of the statewide Curriculum Alignment Project (CAP) which allows guaranteed transfer between participating community colleges as well as CSUs.

The change in number of the Observing and Assessing course as well as the Practicum in Early Childhood Education course is being done at the request of college administration to more appropriately align with current colleges objectives.

Program Description

The Associate in Science in Early Childhood Education for Transfer Degree (Early Childhood Education AS-T) is intended for students who plan to complete a bachelor's degree in a similar major at a CSU campus. Students completing the degree are guaranteed admission to the CSU system, but not to a particular campus or major. A student graduating with Associate in Science in Early Childhood Education for Transfer Degree may transfer to a CSU Campus to complete a Bachelor's Degree in Child

Development, Family and Consumer Sciences, Human Communication, Human Services, and Liberal Studies.

To earn an Early Childhood Education AS-T degree, students must complete:

- 1. Certified completion of 60 semester units or 90 quarter units that are eligible for transfer to the California State University, including both of the following:
- a. The Intersegmental General Education Transfer Curriculum (IGETC-CSU) or the California State University General Education-Breadth Requirements.
- b. A minimum of 18 semester units or 27 quarter units in a major or area of emphasis, as determined by the community college district.
- 2. Obtainment of a minimum grade point average of 2.0 on transfer courses.
- 3. Obtainment of a "C" grade or better, or "P," in all courses required for the major or area of emphasis. Although a "P" grade is allowed (Title 5, Section 55063), it is recommended that students take the course for a letter grade (A, B, or C) due to unit limitations on "P/NP" courses.
- 4. Complete a minimum of 12 units in residency at the college granting the degree.

3. New Program Requirements

This revision changes the course numbering for two courses. The course CD V64A (Observing and Assessing) will become CD V04 and CD V04L (Observing and Assessing Lecture and Observing and Assessing Lab). The unit requirement for this remains a total of 3 units. The second course that has been renumbered is CD V64B (Practicum in Early Childhood Education). This will now be CD V66 and CD V66L (Practicum in Early Childhood Education Lecture and Practicum in Early Childhood Education Lab). The unit requirement for the remains a total of 3 units.

4. Discussion of background and rationale

The proposed AS-T degree TMC pattern in Early Childhood Education completely aligns with the existing courses in the A.S. degree in Child Development as well as the statewide Curriculum Alignment Project (CAP). The proposed degree is designed to prepare students for transfer to a four-year institution for completion of a baccalaureate degree. The mission of Ventura College includes the provision of curricula for students planning to transfer as well as programs for students seeking an Associate's Degree. "With its commitment to workforce development in support of the State and region's economic viability, Ventura College takes pride in creating transfer, career technical and continuing education opportunities that promote success, develop students to their full potential, create lifelong learners, enhance personal growth and life enrichment and foster positive values for successful living and membership in a multicultural society." This degree proposal is clearly aligned with the mission of the college.

The Child Development department offers coursework applicable to variety of careers in the field of education, training, and public service. Students can complete the minimum of classes as required by the California Department of Social Services, Title 22, for entry level employment in a child care setting as well as classes that lead to various levels of the California Early Childhood permit from the California

Commission on Teach Credentialing. Students completing the Associate in Science Early Childhood Education for Transfer degree will be prepared to transfer to several California State Universities where they can complete a related bachelor's degree. For additional information on the early childhood career ladder and both Title 5 and Title 22 requirements, please contact the Child Development department. All students are encouraged to consult with an academic counselor and complete a Student Education Plan (SEP).

Criteria B. Need

- 5. Enrollment and Completer Projections. Not required for an AS-T degree that is aligned with the TMC.
- 6. Place of Program in Curriculum/Similar Programs The current degree is an Associate in Science in Child Development. This degree is designed to prepare students for entry-level positions, update training and career advancement, rather than for transfer to a four-year institution. The AS-T aligned degree will supplement the Associate in Science in Child Development degree that is currently listed in the Ventura College catalog. Both degrees will share existing resources while increasing the college's ability to meet student needs by offering two different degree options a transfer path and a career path.
- 7. Discussion of impact on other colleges in region. Not required for an AS-T degree that is aligned with the TMC.
- 8. Analysis of labor market need or job availability Labor market data indicates an upward trend in employment in professional and business services. Students attain skills from degrees that are transferable across innumerable career pathways. Labor market data is attached to this proposal.
