Included with the updates were a number of courses that had recently been approved or determined to be not approved for CSU GS Breadth that the committee had not previously seen. (courses listed above)

Discussion:

Question: ART V12A and THA V02A - are they being removed and why? Answer: They are skilled-based courses

Comment: It's not necessarily 1 for 1. If something is approved for CSU GE, it would most likely be approved for our local GE. But just because something is deleted from the CSU GE list, it should not automatically be removed from our local GE list.

There was a lengthy discussion regarding this issue and whether or not some courses were suitable for our local GE list. There was a request made to postpone discussion on the more controversial courses until next meeting when more information can be prepared. Group agreed and decided to vote on those courses deemed not controversial. Courses highlighted above were considered and noted on at this meeting. Courses <u>not</u> highlighted will be discussed at a future meeting.

The local GE list for 2017/2018 will remain the same with the exception of the 6 additions. On updated chart, was POLS V18 intended to be on the list? Yes, it will be on the list moving forward – it was already on the list.

The Co-chair of the committee is already an administrator, and VC is in the minority there. Not many colleges do that. Why would we want go further in the opposite direction?

Assigning courses to disciplines, approving pre-requisites, etc. is not the purview of classified staff.


