Minutes and Action Items:

- a. Not sure if we will have a backdoor access to Canvas like we do in D2L, <u>any new news?</u> Mike: Mike, still looking on that. Single Sign on is working well though. Successful in Test Environment. Some User IDs are not matching up. Week or two into production. Still multiple log in challenges is complicated since they are not on our server. This may be a long term problem that we will need to address later, in Fall possibly. Ex: primary way to log in is their password part of single sign on. That is the only way to get in. But during periods of maintenance we need to have an alternative approach for getting into the online classes during those possible times.
 - i. Action: More discussion on going.
 - ii. **Action:** Discussion on how and when to roll out the single sign in. Sharon will create a video for how to do single sign on. Start education of faculty and students. Make transition starting summer.
 - iii. **Action:** Hybrid classes can be coded in banner. Mike will check into the question that arose that we can't do this. It could be a room schedule issue instead.
- b. <u>Discussion item:</u> We need a process to alert Data Techs at all 3 campuses about which courses with Canvas vs. D2I. All Data techs have been trained and codes for the difference of D2L and Canvas have been identified.
 - Action: For exchanage courses how do we go about this for summer and fall.
 Gwen discussed the course cross listing. How to manage the fall exchange.
 Discussion took place.
 - ii. **Action:** Gwen will follow up on timelines and access to the button to go to exchange to see courses. Or are we to train our counselors to make this possible. Also, how do we manage identity of the exchange student.
 - iii. **Action:** Train the trainer would be good for Ashley and Tracie to go through as well as Marc Bowman, with some personalized support from Canvas specifically focused for us. Personalized training will be provided by our canvas training supporter Eddie Sampson. Dave negotiating and covering Cost, will provide more information in upcoming calls.
