Implementation Team Meetings Held

The OEI management team has been conducting on-site kick-off meetings with college implementation teams in preparation for bringing the 16 Exchange Staging Colleges into the course exchange. The implementation timeline calls for the Exchange Staging Colleges to begin technical and programmatic activity to begin registration in mid-to-late Spring 2017 (depending on local registration dates) for courses to "go live" in Fall 2017. The team has visited 18 of the 24 pilot colleges and will be continuing site visits through mid-December. If the team has not yet visited your college, we plan to do so very soon. These visits have been highly productive and represent an opportunity to build shared awareness across all members of a college implementation team, which is providing SPOCs with more up-to-date colleagues on campus with a full perspective on the activities needed to go live in the Course Exchange. In addition, the management team is staffing up support for college support in order to help ensure success (more details will be forthcoming).
