BASIC SKILLS / OPEN EDUCATIONAL RESOURCES

OER: SB 1359 (Block) was signed into law. This bill will require colleges to disclose in course catalogs which courses use exclusively Open Educational Resources (OER). All materials must, of course, comply with the federal Americans with Disability Act of 1990 and the federal Copyright Act of 1996. The provisions of the bill will apply to courses offered after January 1, 2018.
