- E. Martinsen replied that the department went back and forth on that, and stated that if it is the will of the committee to add, he did not think the department would object.

It was noted that the courses from List A should be detailed in List B and Lisa A and B courses should be listed in List C.

D. Farris noted that the courses ENGL V30/V31 were listed under List B on the catalog narrative and "College Program Requirements" column of the TMC template whereas they are listed under List A on the "Transfer Model Curriculum (TMC)" column of the template. E. Martinsen agreed to move them to follow the TMC column of the template, under List A.
