#### III. Action/Information/Discussion

#### A. Committee Survey Results (Information) - P. Sezzi

Peter asked the Committee to review the results of the survey. He asked if there were any questions. Raeann Koerner asked for clarification on question #4 dealing with specifically a response dealing with courses being submitted for approval and then not being approved to be offered.

#### B. KIN Program Changes for Fall 2012 (Information) – ,G. Arevalo

During the summer a state mandate was received indicating that program codes for KIN courses that are part of the KIN degree be changed effective Fall 2012. All KIN courses were submitted to the state with the new TOPS code and have been approved. Due to this change, we are hoping to now submit our KIN transfer degree. TOPS code stands for Taxonomy of Programs.

#### C. <u>Title 5 Changes – Repeatability (Information) – G. Arevalo</u>

There are new regulations on repeatability that will require us to change various courses with repeatability. There are currently 131 courses that will be affected by this change. The areas affected are: Art, Arch, ACT, Bus, CD Cog, CT, CJ, Drft, EAC, Engl (1 course), GIS, GEOG, GW, IDS, KIN, LS, MT, Mus, Photo, THA and WEL. All this changes have to be in place by Fall 2013. A decision needs to be made on how to approach the revision of all these courses. Ramiro participated in a webinar regarding this change. He mentioned that it was said that the approach of creating families for these courses should be taken very conservatively.

### D. TMC and C-ID Update (Information) – G. Arevalo

VC is 2<sup>nd</sup> in the state with approved transfer degrees. Advising sheets for the new transfer degrees were distributed and list information for these transfer degrees. The following transfer degrees have been vetted and may want to consider: Education, English, Geography, Geology, Mathematics, Music, and Physics. The vetting has been closed for the following: Anthropology, Chemistry, Biology, Philosophy, and Spanish. Vetting is being considered for the following: Radio, TV and Film, and Social Work. Email Gloria to obtain the link where all this information can be found. Angelica Gonzales asked if CID numbers will be added to CORs. Gloria said that currently there's no physical spot where we can include this information. We will need to work with Governet on this. She mentioned that once we have a course approved through CID it is considered state approved.

#### E. 2012-2013 Catalog Addendum (Information) – G. Arevalo

Gloria is working on an addendum to the 2012-2013 catalog. She advised everyone to look at their own sections and forward any mistakes to her.
