SECTION THREE: DISCUSSION (CONSENT and/or ACTION) III. Action/Information/Discussion

A. Carnegie Unit Override (Discussion) – Raeann Koerner

Units to Hours Calculations were discussed. Raeann presented the Title 5 section 55002.5 to the Committee; it permits courses to be proposed with flexibility in the hours to units calculations. Ramiro stated that we are proposing a norm of normal hours to units calculations. Most activity courses throughout the State are a one unit course, with three hours lab. Although variations can be seen throughout the State, but we would like to create a norm for our college. Mark also commented that the straight Carnegie Units calculations will ensure us that our courses are in compliance and are safe for any changes in the future. The proposal should best serve our students. Tech Review Committee reviewed these technical issues to safeguard proper alignment with rules and regulations and looking upon the wider perspective of what is going to happen in the future if we approve such a proposal. We would rather be conservative than get a rejection from the State.

Mayo commented that maintaining the anatomy of the course is within the purview of the faculty. There should be flexibility for hours to units calculations as permitted. Alex stated that faculty should be able to present their courses and justify why they are proposing such calculations. Bob identified that the lec-lab hours were the right combination for the courses that ART is providing for students. When the Art Department have to make this change, we made sure that our proposal has the right amount of hours even though it is not a straight Carnegie unit calculation.

Michael stated that he had done research on many editions of PCAH. The problem is there needs to be an interpretation. One unit equals to three hours of experience for an integrated lab course, in which two hours are dedicated to the lab and one hour dedicated to outside work. There is no evidence prohibiting the hours that we use for lec-lab calculation. Gloria said that we have not documented on how we dedicated hours to lecture, lab content and outside class assignments for our lec-lab courses, and that makes our courses out of compliance. She also pointed out that Integrated lab is only for lab courses. Michael further said that currently as he reviews courses that are submitted in CurricUNET, he is documenting hours devoted to lecture, lab, and outside class assignments. Regardless, all departments must insert the lab content, and the hours when revising the CORs.

The Action was to get counsel from the State, Tech Review will have a discussion with certain Departments on revising the units/hours, and come back to vote on the next Curriculum Committee meeting, December 4, 2012.

Ramiro stated that at the last DTRW-I meeting, Oxnard College presented the largest numbers of new and revised courses and degrees. There were some recommendations to our degrees that were submitted. He also mentioned that our courses and degrees were pulled from DCCC due to that it did not get on DCAA agenda. We are awaiting a special one-time permission to submit our courses and degrees to BOT, bypassing DCAA in order to get them approve in December.
