C. Philosophy & GE Sub-Committee (Information) – M. Pauley/G. Arevalo Mark informed the committee on the discussion that the District-wide Philosophy & GE group had discussed at their last meeting. They will also be meeting on December 5, 2012. Part of the discussion was that the list of comparable courses was not quite aligned. GE committee will review this list next Spring and come to the consensus to eliminate any anomalies on the list.

The District-wide GE group will make some minor revisions to AP/BP 4025. The group will propose to revise the section of the AP that references SLOs as criteria to determine GE placement. Ramiro also added that this is more of a long term plan to help students achieve their transfer degrees.

D. Title 5 Regulations – Prerequisites (Discussion) – R. Sanchez/M. Pauley Ramiro stated that Title 5 regulations are allowing colleges to adopt prerequisites and corequisites by a content review process. This method can be used as an alternative mechanism for a college to recommend new prerequisites. Previously there are two methods that can be used to recommend prerequisite. One of the method is finding a lower division CSU's equivalent course and recommend the prerequisite course that are adhere to it. Second is by using the statistical analysis review. If there is no equivalent course at the CSUs, the department will have to conduct a fiscal analysis and validate it through assessments. This method takes longer time and requires more resources.

E. SB1440 Student Transfer Achievement Reform Act and SB 1415 Common Course Numbering System – C-ID and AA-T/AS-T Degrees (Information) – R. Sanchez/G. Arevalo

Gloria explained the memo from the State Chancellor's Office that was sent out to all California community colleges in regards to the timeline to amend all active AA-T and AS-T degrees to include C-ID descriptors and a new transfer degrees proposal submission process.

Effective January 1, 2013 all transfer degrees proposals submitted to the State for approval must demonstrate that courses included in the degree have been submitted for C-ID numbers, where descriptors exist. By June 1, 2013, our existing transfer degrees must be amended to include C-ID descriptors, where they exist. By June 1, 2014, colleges must replace all course-to-course articulation used for all transfer degrees with C-ID descriptors, where they exist. The State will begin deactivating all non-compliant transfer degrees beginning June 2014.

Gloria asked for faculty to look into courses included in their existing transfer degrees for discrepancy between CORs and descriptors. If so, faculty should revise the course as soon as possible. She will also establish a contact person for Raeann to get clarification on KIN courses.
