- III. Action/Information/Discussion
  - A. Instructional Materials Fee (Update) R. Sanchez
    Currently, campuses are not charging for instructional materials fees
    due to direction from the district office. All departments that were
    impacted were told to purchase the materials and the EVP office would
    cover the costs with the intent of a resolution. Since then, the State
    Chancellor's Office sent out a Title V update. It delineates the
    parameters on what districts can do. Marianne McNeil from the district
    office will be attending the March 21<sup>st</sup> Admin Council meeting to provide
    for information.
  - B. Statewide Student Success Task Force (Information) R. Sanchez Ramiro told the members to check out the PDF files on the State Chancellor's website under statewide task force to be up-to-date on the current changes.

C. Regional Curriculum Meetings (Information) – M. Pauley
Mark mentioned that a few people are sent to these regional meetings.
They are currently trying to decide if they should have them or not. On
the attachment that was provided, there's a small survey link that

a. <u>Standardizing College Catalogs</u>: Ramiro mentioned that an idea came forth for all 3 colleges to standardize all catalogs to make them more consistent.
