A. Stand Alone Courses (Action) - R. Sanchez/J. Ferguson P. Sezzi

Per Title 5 changes, certification needs to be submitted to the State Chancellor's Office that any person who touches curriculum has been certified through a stand alone course training. A handout was distributed by Peter where he indicated to the committee to refer to handouts 2, 3 and 4 for reference.

B. Syllabus...Changes in Requirements (Action) - J. Ferguson

Accreditation standards require that students receive a course syllabus for every class section specifying the learning objectives consistent with those in the institution's officially approved course outline. It was strongly recommended and approved by the committee that all divisions/departments have a syllabus on file for all their courses being offered.

C. <u>DTRW Changes in Course Approval Process (Information) – J.</u> <u>Ferguson</u>

A handout, which incorporates revisions agreed upon DTRW on December 18, 2008 and January 22, 209, indicates which courses need to be submitted to DTRW for review and Board approval and which courses require college Curriculum Committee review only.

D. <u>Variable Units & Topic Courses (Information) – J. Ferguson</u>

Handouts on excluded variable unit courses and topic courses: V60 series that are slated for deletion because they have not been offered in the past 5 years. The goal for the deletion of the topics courses V60 series is to eliminate all topics courses (convert some to regular courses) from the VC curriculum and retain only the workshop series in order to comply with the CCCCO directive.
