Dear Claudia Wilroy,

Thank you for all the work you put into completing your comprehensive program review. It has been reviewed by the College Planning Committee and the Executive Team. The College Planning Committee feedback is attached. Below, you will find comments, commendations, and recommendations from the Executive Team. These are provided for incorporation into your annual program planning processes. Typically, recommendations require planning improvements that will be implemented over time. Thus, in your subsequent annual mini reviews, you will want to provide updates on progress made towards addressing these recommendations.

Comments:

- The program currently serves 55 international students from countries such as Australia, Belgium, Brazil, France, India, Pakistan, Canada, and Thailand, to name a few by offering the following services to all international students: a complete admissions process: a review of paperwork needed, financial statements, high school completion, English proficiency, etc., visa appointment & immigration advising (F1 regulations only), change of status assistance, internship/externship & employment opportunities on and off campus.
- The program also assists all students with housing, transportation, bank accounts, phone purchases, health insurance, and navigating the American life in the U.S.
- The program intends to grow by 20% in three years.

Commendations:

- 1. The program, with a 30% position, actively supports our international students on and off campus, including all international student athletes.
- 2. The program has increased the number of international students attending Ventura College and will continue to grow.
- 3. Many Canadian students (no visa required) are currently attending the campus as student athletes.

Recommendations

- 1. Identify a Principal Dedicated Student Officer position for Ventura College.
- 2. Develop a strategy to investigate international marketing website ads in international platforms and attend agents' events globally.
- 3. Increase the number of agencies/partners working with the department.
- 4. Promote more events on campus to engage the international students, not only amongst themselves, but also with the local students.

PC's overall recommendation is to strengthen the program, to which I concur. Thank you again for your dedicated work in improving outcomes for our students.
