	a) Tenure Portfolios	Tenure Portfolios and ADA compliance - portfolios are not for a general audience or the public. Unless reviewers need accessible content, ADA/accessibility is not required.	
	b) Waitlists and Enrollment	<ul> <li>Waitlists as an enrollment management strategy – one size does not fit all</li> <li>In response to question from chairs, yes, we can pull waitlist details and reach out to students with other section options for example.</li> <li>Intent is to have Office of Academic Affairs to work with Division Offices to develop a plan for reaching out to waitlisted students.</li> </ul>	
	c) CARES Spending Update	- Will be revisited in November.	Place on Nov agenda.
	d) Online MAX CAPS follow-up with data	<ul> <li>Office of AA collected data from CCs. Where possible, contact was made to request information pertaining to MAX CAPs. Alternatively, data was based on publicly available schedules – data may be presented in range format.</li> <li>MC and OC originally requested a 45 max cap, but VC opted to ask for a cap of 40. This seems to be in line with our neighboring colleges in neighboring counties.</li> <li>Waitlist flexibility will be an important tool in managing the enrollment if we shift to lower max caps.</li> </ul>

	<ul> <li>Academic Senate asked if there is a desire for a formalized process to set a practice for enrollment management – ie. An enrollment management committee?</li> <li>Is there any consideration to uncouple summer from the fall? Summer will most likely need to be planned to be online. Decision on Fall 21 schedule will be made in early December. Uncoupling requires a lot of IT work, so ideally, we would avoid this if it is not necessary-ie if Fall ends up being online as well. <ul> <li>Chairs would appreciate the opportunity to weigh in on this decision.</li> </ul> </li> <li>Is there any consideration to hold dropping students for non-payment? VPs across the district requested to drop this policy during Covid. If this request isn't accepted, the alternative would be to push back the deadline to census, and to also reconsider timelines and deadlines with regards to the student payment plans. Our payment plans and options are not well communicated to students. VPs would also like to run a calling campaign to reach out directly to students. As a campus, we also need to recommit to getting census reporting done on time.</li> </ul>
