More information should be forthcoming Question: with Dean of Student Services position now empty, who is leading BICT and Title IX? VC will be looking for an Interim Dean of SS, but in the meantime, VPSA will be overseeing these areas. There were concerns with VPSA leading BICT reporting before and therefore Chairs are concerned about this being returned to the VPSA in the interim. Perhaps another VP could lead this.
