FY21 Budget and Year to Date Actuals as of October 31, 2020

The following pages provide information on FY21 (20-21) SEA expenditures by program. The first page shows a summary by program that was shared with the Budget Resource Committee (BRC) on September 16, 2020. The SEA budget for FY21 was comprised of two funding sources: carryover from the prior year of unspent FY20 SEA allocation (org code 36515), and FY21 SEA allocation (org code 36516). The second page shows the breakdown of total expenditures through October 31, 2020 by program by the funding source (org code 36515 or 36516). That page is followed by detail reports (FYSODTL) that show the line item year to date expenditures subtotaled by program code for the FY21 SEA (org code 36516) and FY20 SEA carryover (org code 36515).

There are several things to be aware of when reviewing the detail reports to assist you in analyzing the data.

- The detail reports are run by account by program. Not all the program codes in our financial system (Banner) match our locally used descriptions. For example, program code 639010 is listed in Banner as “Other Student Counseling & Guidance Special 1” and has been locally designated as “Career Center”. The program codes and their locally designated descriptions are available on the second page summarizing expenditures by funding source. The locally designated description is also listed on each page under the budget and year to date totals.
- A full list of account code descriptions, as well as organization and program codes, can be found on the BRC website under [Budget Report Information and Descriptions](#).
- Some funding sources allow funds to be spent over several years. In order to track the expenditures over multiple years, account code 7991 is used in the current year to identify prior year expenditures. When reviewing the detail report for FY20 SEA allocation (org code 36515), please note YTD amounts listed under account code 7991 are amounts spent in FY20 and listed in FY21 for information and tracking purposes only.
