

Proposal for AY 2021-2022 Curriculum Co-Chair

Discussions in the curriculum committee this past year (2020-2021) have included numerous faculty voices agreeing that the current curriculum workload/backlog of courses and programs, coupled with relatively low release time relative to this workload, have resulted in no faculty member nominees for the upcoming vacancy in the position of faculty co-chair of this committee.

This proposal seeks to address the following concerns via a change to the release time compensation structure of the faculty leadership of the curriculum committee.

1) Current curriculum practices are complex and not fully understood by faculty members wishing to submit courses and programs, or understood by all faculty members serving as faculty representatives on the curriculum committee. A curriculum work group has been working since January 2021 on addressing this through the creation of a Canvas shell designed to educate faculty stakeholders on these processes. This work remains far from complete.

2) The VC Academic Senate has offered to invite the ASCCC (Academic Senate of the California Community Colleges) to send a <u>technical assistance visit</u> so that state curriculum experts can evaluate, educate, and inform us (the Curriculum, and its new leadership) on best practices moving forward.

3) Multiple faculty from multiple areas will be needed to meet with the ASCCC technical assistants, formulate a plan of action in response to their recommendations, and work collaboratively on implementing this plan.

For these three reasons, the current proposal for Curriculum Committee Faculty Leadership in the 2021-2022 academic year is:

1 Curriculum Committee Faculty Co-Chair: 0.4 release time:

-all current duties of the chair, and

-coordination of the ASCCC technical assistance visit work.

4 Curriculum Committee Faculty Tech Review Assistant Leads: 0.1 release time each for duties including:

-traditional curriculum technical review assistance,

-ASCCC technical assistance visit work, and

-completion of a VC curriculum process educational/training to be available to other Curriculum Committee members, as well as faculty and other stakeholders across the campus.

The new Faculty Tech Review Assistant Leads would be selected by the curriculum committee (from a diversity of areas) on a one-year trial basis. Their primary goals will be to respond to ASCCC recommendations and complete the educational/training materials. Because their work also includes traditional curriculum technical review, their release time may come in part from the release time currently allotted for the technical review chair.

At the end of the 2021-2022 academic year, the efficacy of this proposed leadership change will be assessed. Possible outcomes include: a) abolition of the four tech review assistant lead positions and no change to the release time of the faculty co-chair, or b) abolition of the four tech review assistant lead positions and an increase to the release time of the faculty co-chair, or c) extension of the proposal through one or more subsequent academic year, or d) any other recommendations the curriculum committee has regarding the faculty leadership structure of the curriculum committee.

Item 1. Program Goals and Objectives

The goals, objectives, program student learning outcomes (PSLOs), and occupational preparedness of the Ventura College Social Media Marketing Program are presented below.

The Ventura College Social Media Marketing Program is designed with the goal of enabling students to develop skills and strategies to integrate social media into the conventional marketing variable mix.

Social media is now inextricably embedded in the current business environment. Social media has changed the way businesses communicate with their target market, customers, and other businesses. It has also changed the skills needed by today's business workforce. The inclusion of social media for market planning can mean success or failure of a business plan.

Below are some survey results from the 2013 Social Media Marketing Industry Report: (<u>http://www.socialmediaexaminer.com/SocialMediaMarketingIndustryReport2013.pdf</u> Accessed 09-21-14)

- 86% of marketers said that social media was important to their businesses.
- 88% of marketers want to know more about the most effective social media tactics and ways to increase engagement of their target market using it.
- 89% of all businesses reported that use of social media increased their market exposure.

The U.S. Bureau of Labor Statistics (BLS) combines social media specialists with other types of public relations specialists. According to the BLS, "these workers might go by various job titles, including digital engagement specialist, social media strategist, and online community manager". The BLS reports that "in May 2015, there were about 218,910 public relations specialists working in wage and salary jobs, according to the BLS. Their median annual wage was \$56,770, higher than the \$36,200 median for all workers. These data do not include employment and wages of self-employed workers." (https://www.bls.gov/careeroutlook/2016/youre-a-what/social-media-specialist.htm Accessed 02-12-20)

Social media allows businesses to cost effectively reach out to consumers on a more frequent basis than conventional marketing, thereby increasing exposure to their target market. It allows for specific targeting of individual consumers, reaches a more expansive market through mobile technology, and enables interactivity between businesses and consumers. In addition, social media helps to develop brand awareness, provide customer relations management for existing customers, and acquire new business.

For social media marketing to be effective, it is important that it be strategically implemented. This requires education and training in this new age media.

The objectives of this program are as follows:

- Explore factors that drive social media
- Understand social media networks
- Utilize effective communication strategies in social media
- Identify and analyze social media marketing opportunities
- Learn how to design and implement social media strategies
- Learn how to integrate social media into a business marketing plan

Item 4. Master Planning

As was stated in page one of this narrative document, social media has become a powerful force that is now being harnessed by the business world for use in reaching target markets and developing ongoing relationships with customers. Social media has changed the way businesses communicate with their target market, customers and other businesses, and the skills needed by their workforce. The Social Media Marketing Program at Ventura College meets the needs of businesses, both locally and globally, by providing education and training in the incorporation of social media marketing into the integrated marketing plans of businesses.

According to the Economic and Workforce Development Small Business Survey for the South Central Region, employers reported that marketing and promotion were barriers for many small businesses due to the time and complexity involved in them. They reported that increased marketing skills would be likely to help them move their business to the next level. Nearly 60% of those surveyed indicated an interest in learning more about social networking and on-line presence and 65% wanted to learn more about marketing. (Small Business Survey, April 2014, Economic and Workforce Development through the California Community Colleges). This program fills a need in the business community by providing the educational opportunities businesses are requesting and providing a trained workforce to contribute to these businesses. It also aligns directly with the California Community Colleges' *Doing What Matters* program for the Small Business Sector. The goals of this program include "Increase the success of business through partnerships and collaborations with industry, education and government" and "Expand entrepreneurship curriculum across community college campuses."¹

The Bureau of Labor Statistics reports that "in May 2015, there were about 218,910 public relations specialists working in wage and salary jobs, according to BLS. Their median annual wage was \$56,770, higher than the \$36,200 median for all workers. These data do not include employment and wages of self-employed workers."

The Centers of Excellence (COE) environmental scan on Social Media documented that social media occupations are predicated to grow "at an average of seven percent over the next 5 years."² Their data also indicates that businesses surveyed indicated a need to update the skills of their current workforce. This report states that "California Community Colleges are well positioned to build a pipeline of skilled workers, create and expand industry partnerships, and meet existing workforce needs in social media and future needs as they arise."² The COE indicates that the community college system has the opportunity to develop courses in social media and professional certificates. Ventura College's Social Media Marketing Program is doing just that. We have created courses in Social Media Marketing, Marketing, Public Relations, and Sales as well as an Associate of Science Degree and Certificate of Achievement in Social Media Marketing. Labor market reports can be found in the attachments.

Currently there are only six other California Community Colleges offering a program in social media or digital marketing and none are in our college service area. Santa Barbara City College offers two courses in the use and creation of social media content, but these courses are computer technology courses and are not specifically for the use of social media in the marketing plans for business.

The Centers of Excellence environmental scan on Social Media shows that occupations in this field are growing at a rate of 7%. The *Economic and Workforce Development Small Business Survey for the South Central Region* demonstrates that over 60% of small businesses are interested in either use of social media and/or learning more about marketing for their companies. Additionally, it is important to note that these statistics do not account for the number of employers seeking employees with additional skills in social media marketing. Therefore, a comparison of the completer projections and the labor market demand demonstrates that this program will be beneficial not only to program completers who seek employment in related careers but also for incumbent workers and business owners.

In addition, the Committee monitors compliance with Accreditation Standard IIA. A complete overhaul of the curriculum process is needed - more efficient and effective methods of reviewing and approving courses and programs is needed. There is far too much work for the chair and tech reviewer to effectively manage. Chair needs more than just 40% release - should be 100% until the entire backlog is cleared and new processes can be established.

(Don't panic—not all of these must be addressed immediately or concurrently—but some do!)

- 2023 Accreditation visit: Updating and validating ACCJC Standard II.A. in the ISER, and determining the fates of courses for which SLO assessments are not available (e.g., courses not offered in the last five years)
- CourseLeaf CAT (online catalog) implementation
- Implementing Credit for Prior Learning (CPL) processes and procedures, and determining which courses are suitable for the various CPL "modalities"
- Continuing to reduce the program backlog in CourseLeaf CIM
- Training the new leadership (new co-chair(s) and, likely, new articulation officer) and allocating responsibility for tasks (while not letting essential tasks and deliverables fall through the cracks)
- Internalizing recommendations that we receive in the wake of the ASCCC Technical Assistance visit
- Identifying and training technical review leaders and implementing new or modified curriculum processes to best leverage these new positions
- Identifying a succession plan for when Michael Callahan retires or steps down as Curriculum Technical Review and Prerequisites Workgroup chair
- Updating existing ADTs for (1) revised TMCs and (2) adjusting GE and double-count numbers¹ to account for the new CSU ethnic studies requirement (CSU GE-Breadth Area F)
- Determining a process to maintain CourseLeaf CIM to reflect organizational and workflow changes at the college (recommendation: should probably not be delegated to IT)
- Maintaining communication with the CourseLeaf vendor (likely to consist largely of CIM and CAT bug reporting and fix testing)
- Maintaining curriculum quality and conformance while streamlining review processes
- Avoiding the temptation to delegate 10+1 curriculum responsibilities to classified professionals or management just because they are more experienced or knowledgeable
