A. First Year Experience Task Force Seeks Volunteers – D. Clark, D. Farias,J. Kalfsbeek-Goetz

D. Clark: At last Senate meeting, there was a discussion about First Year Experience. There are a list of courses that qualify for this experience, and faculty are interested in getting their courses on this list. A taskforce needed with some faculty from Curriculum Committee and some from Senate, to come up with a transparent process to decide which courses can be counted towards the First Year Experience program.

J. Kalfsbeek-Goetz: This is an information item right now. Volunteers can come from anywhere – not just faculty involved in Senate or Curriculum.

D. Clark: We would like to have volunteers set by March to begin meetings.

J. Kalfsbeek-Goetz: Want to remind everyone that we need to go through the regular Curriculum process to add DE addendum. Classes have to have an addendum attached to them in order to be offered in fall 2021. February 11th was the deadline – there is not much on the list so far. Dept. Chairs and Deans need to use the link they were provided in an email to indicate which courses need an addendum for fall. Any that do not have DE will be removed from the fall 2021 and summer 2021 schedule.

K. Denton: to our knowledge, the issue has been fixed and we can start pushing courses through that have been stuck at the Banner step. Upwards of 10 minutes per course at 500 courses – time consuming workload. Good news is that it seems like it's working, and we are able to have a manual sync to CourseLeaf twice a day to get them pushed through. CourseLeaf is unavailable to the campus 12-1pm each day to help in this process. This will continue for several weeks until backlog is done.
