Course Description:

This course offers an introduction to the history of modern agriculture, including its integration in social, economic and political institutions, its biological systems, the causes and impact of world hunger, and the implications of future changes and innovations in the production of food and fiber. The course will emphasize critical analysis of agriculture within the United States and California, both from a historical perspective as well as the present situation and current issues. The focus is on increasing awareness of the prevalence and importance of agriculture, and its impacts on nearly all aspects of modern daily life.

In light of the new CSU Ethnic Studies requirement (AB 1460), the history department has decided to break the co-listing relationship between HIST V79 and AES V61, and then to **inactivate AES V61** while **retaining HIST V79**.

The appended email thread serves in lieu of the usual department chair notification we require when a course is to be inactivated. If you retain an archive of course inactivation notifications, please add this message to that archive to document why AES V61 will not appear in the next catalog.

The applicable proposals (revision of HIST V79 and inactivation of AES V61) should be making their way through CIM fairly soon; the originator will likely be Scott Corbett, who will be returning from retirement to teach for us as an adjunct this spring and perhaps beyond.

Dear Esteemed Colleagues,

I am writing this with regards to the status of our efforts to construct a solid and genuine American Ethnic Studies program in light of the new expectations regarding such courses from the CsU system. This is the essence of the Academic Senate for the CSU resolution:

RESOLVED: That the ASCSU recommend the adoption of the following five core ethnic studies competencies iteratively developed by the CSU Council on Ethnic Studies and the ASCSU:

- analyze and articulate concepts of ethnic studies, including but not limited to race and ethnicity, racialization, equity, ethno-centrism, eurocentrism, white supremacy, self-determination, liberation, decolonization and anti-racism.
- apply theory to describe critical events in the histories, cultures, and intellectual traditions, with special focus on the livedexperiences and social struggles of one or more of the following four historically defined racialized core groups: Native Americans, African Americans, Latina/o Americans, and/or Asian Americans, and emphasizing agency and group-affirmation.
- critically discuss the intersection of race and ethnicity with other forms of difference affected by hierarchy and oppression, such as class, gender, sexuality, religion, spirituality, national origin, immigration status, ability, and/or age.
- describe how struggle, resistance, social justice, solidarity, and liberation as experienced by communities of color are relevant to current issues.

Here is the course catalogue description of Hist V79 (which is cross listed as AES V61)

HIST V79 - INTRODUCTION TO THE HISTORY OF EAST ASIA : 3 Units Hours: 3 lecture weekly This course will present a historical survey of the countries and cultures of East Asia with a principal focus on China and Japan. An emphasis will be placed on the impact of traditional Chinese and Japanese antiquity on the present, the impact of the culture and heritage of each nation on the other, and the impact of the West on both major nations. Field trips may be required. Formerly Hist 15 and HIST V15. Same as AES V61. Transfer credit: CSU; UC; credit limitations - see counselor.

I simply do not see how Hist V79 really has any content in it that would enable it to fulfill the expectations the CSU has for America Ethnic Studies courses.

Therefore, I respectfully request that I be permitted to update Hist V79 (preparatory to offering it as soon as the process is completed) by eliminating the cross listing. Concomitantly, AES V61 should be deleted from

the catalogue as I do not see how we could revise that course to make it a suitable American Ethnic Studies Course.

In order to effect the deletion of AES V61 we [Curriculum Gurus] would need a brief memo from the department chair, addressed to Michael Callahan, Sarah Ayala, and Michael Bowen, stating that the inactivation was agreed to by department faculty and not coerced by any manager. Once that is done, then I can get started in updating Hist V79.

I hope you all can see the simple logic of all of this and agree with this plan of action.

3. Describe the intersection of race and ethnicity with other forms of difference affected by hierarchy and oppression, such as class, gender, sexuality, religion, spirituality, national origin, immigration status, ability, and/or age;

4. Describe how resistance, social justice, and liberation as experienced by communities of color are relevant to current issues (communal, national, and international); and

5. Demonstrate active engagement with issues of race and ethnicity to build diverse, just, and equitable communities beyond the classroom.
