#### Transferring GE Approvals/Grandfathering Local GE Approvals in Areas Α. C1 and F from Previously Inactivated Course (Information; 10 minutes) -P. Sezzi. M. Werness-Rude

M. Callahan: As a general rule, a few years ago, it was decided that courses approved at CSU for GE would automatically approve them in our local GE in that specific area. If discipline is opposed to that, it can be discussed. This issue arose when a previously inactivated course was reactivated – should we automatically grant it the past local GE designation? This refers to the VC local GE designation only.

Chloe was approved at the last Senate meeting as returning CC member. Kafui Okosun also new member for the CE1 division.

#### B. Procedure for Review and Approval of Honors Courses (Discussion – 10) minutes) - P. Sezzi, M. Werness-Rude

Should we have a plan for this as a curriculum committee? The new honors courses have not yet been tech reviewed.

How should we approach these new courses? Currently there are 9 courses.

Jen – Development of the Honors program – last year we talked about what we wanted the program to look like, equity issues, ben building it with the notion that any student that takes an honors course is an honors student. Pathways within the honors program. Faculty led initiative. Welcome all students, equity driven. Criteria set by honors association for courses.

Could be cross-listed with non-honors counterpart course.

Equity grounded rubric should come to the Curriculum Committee for discussion and decisions.

M and P can develop a larger document to re-submit to the committee as an action item.

Cart before the horse? The process should have been decided before courses created.

Would be helpful if the Committee could see a side by side of Honors course vs general course. Could make decision a little bit easier, give it structure and framework.

Questions:

Are these stand-alone courses? Honors course – separate course outline of a course that already exists that has separate components. Does not increase their GPA at the college level.

Increase of units? Shouldn't be quantifiably more work, but the nature of the work. Changing the units would be challenging and would create higher unit programs.

Curriculum Committee group would like to invite the faculty who helped develop these to come to CC for discussion. Group would like to see outline of criteria. 9 courses currently in the queue – are we ok with them saying in a holding pattern until this discussion has been had? Course authors should be contacted to they are aware. Ask them for help in developing the new rubric for honors courses.

Do we have a rubric for regular technical review? Moving forward, we should have a specific rubric for this as well.
