TOPIC: COVID-19 SITE CONTROLS

Dear Mr. El Fattal:

On October 15, 2020, Keenan & Associates had the pleasure of conducting a specific site walk reviewing campus sites during this unprecedented period. The review of the locations was to reidentify the control of movements of any students, general public, and the review of COVID-19 access to the campuses. This service was provided as a benefit of membership in the Statewide Association of Community Colleges (SWACC).

On July 1, 2017, SWACC developed a comprehensive, proactive, hands-on Loss Driver Reduction Program (LDRP). In an effort to target losses both globally in SWACC and within individual members, this service allows a Loss Control Consultant to spend one 6-hour day/month, for one year, at each of the identified member districts (7-9 members per year) to create and assist in the implementation of a member-specific Loss Driver Reduction Plan (LDRP).

This is a hands-on, proactive approach providing Loss Control staff as "boots on the ground" resources to act as a direct on-site extension of the member's risk management program.

Starting July 1, 2019, Ventura County Community College District began its LDRP; however, at the end of the twelve (12) month period (June 30, 2020), two (2) monthly services had not been provided due to either site shut-down or no service required at the time. This report depicts the last of the two (2) make-up dates to ensure the District receives the full twelve (12) month increments.

Please note that all services are intended to address Property & Liability losses, both experienced and anticipated that can impact the District and SWACC. Some services that may be considered when the consultant and the member meet to review your historic loss drivers and create the LDRP could include (but are not at all limited to):

- Hazard assessments/safety inspections (COVID-19 Site Controls)
- Anything P&L safety/loss related

One location was found not to be signed up regarding the required access point through EAST Parking Lot. Suggest adding a required Prescreening sign board at this access point off Telegraph Road (Photos 10 and 11).

OXNARD CAMPUS

Site Access

The site continues to take positive steps in the control of students in this unprecedent time with only essential curriculum being held with in-class attendance. The entire inner campus area has been cordoned off with construction safety fence (Photos 12 and 13) to control student, staff, and general public movements.

All meeting/equipment areas have been taped off to prevent socializing (Photos 14 and 15). Other than Parking Lots A and B, all other parking lots and campus roads have been closed to minimize movements. All visitors are required to park in Lot A and B, and enter the campus through the COVID-19 prescreening testing area (Photos 16 and 17).

The goal of our assessment was to (i) promote safety awareness, (ii) assist in the identification of conditions which may pose a risk of injury and/or property damage, and (iii) provide recommendations and/or suggestions to help mitigate the risks identified. Site Specific Findings

A few areas of concern need to be addressed in which either fencing has been surpassed by individuals taking a shortcut. It appears individuals have left the quarantine area (Photos 18 and 19) and reentered at the Library (Photos 20 and 21).

Other locations show evidence of individuals having climbed over fencing (fence damage) to take shortcuts (Photos 22 and 23). These areas are found at the West end of Administration and the East end of Administration respectively.

MOORPARK CAMPUS

Site Access

The site has taken positive steps to control the flow of students in this unprecedent time with only essential curriculum being held with in-class attendance. The entire inner campus area is controlled by allowing students, staff, and general public to enter the site at a total of five (5) locations only.

Three (3) entrances are located at Parking Lots PA, M, and F, with all other parking lots (Photos 26 and 27) and campus roads being closed to minimize movements. A fourth entrance is located at Collins and Moorpark College Road adjacent to the Maintenance Yard. The final, and newest, location can be found at the College Zoo, allowing access for essential staff and students.

All visitors are required to park in the identified parking lots and enter the campus through the COVID-19 prescreening testing area (Photos 28 and 29).
