Updated Nuventive software for program review and SLOs. The current software that we are using is out of date, and will no longer be supported by Nuventive. The current system also has a number of issues, including:

- dept chairs having difficulty logging into the system
- data dashboards not loading correctly
- inability to display committee rubrics within the system when people are requesting resources
- inability to export/print a full program review
- incorrectly categorizing resource request types (i.e. technology vs. equipment)

- numerous back-end technical issues that require extensive time and workarounds to deal with The updated version will fix all of these issues, as well as provide a number of interface

improvements. It will also allow us to easily incorporate the "closing the loop" process that is being developed by CPC. It will also allow programs to more easily track their program data and objectives.

Q4. Why was this request not included in the annual program review process?

The software update was not available until after the program review process was completed.

Q17. Why is this request needed at this time (as opposed to going through the annual program review process)? Please describe how your program will be impacted if this request is not approved.

If we do not update this now, we will continue to have the issues noted above in next year's program review. We may also see system crashes, given that the system is on its last legs, and Nuventive support for it is waning. By updating it now, we can implement the updated system this spring/summer, and have it ready to go for next year's program review.

Q12. Estimated Cost

\$32,900 next year. Then, \$36,000 in subsequent years. We are currently paying \$12,000 a year, so the increase in cost would be approximately \$20,000.
