Dear Dr. Rasmussen-Hagerty:

Congratulations! At its November 3-6, 2022 meeting, the AVMA Committee on Veterinary Technician Education and Activities (CVTEA) **granted Initial accreditation** to the Ventura College veterinary technology program after deliberation of the report of evaluation from the August 24-25, 2022 site visit and post site visit response. Accreditation is effective <u>August 25, 2022</u>.

A final copy of the report of evaluation is included and also uploaded under the DOCUMENTS area in the CVTEA Accreditation Portal by Armature (Armature). A copy will be sent to college administration as indicated in the near future. Included below is a summary of critical and major deficiencies with details regarding future reporting requirements.

After consideration of the documentation provided, the Committee has determined that continued reporting is required on the following deficiencies (see chart(s) below):

Critical deficiency(ies): 1a,2,3,4,5,6,7 and a NEW CONCERN (noted below)

Major deficiency(ies): 1,3,4,5,7 (noted below)

The next report will be due Fall 2023 (September 15, 2022). A reminder will be sent out approximately 2 months prior to the due dates. The next full accreditation site visit is scheduled for 2027.

For your information, the Program will be assessed an annual accreditation fee beginning in year 2024. This fee is assessed to recover 50% of the annual direct and indirect costs of accreditation over and above site visit expenses. The current fee is \$1,860; however, this fee is adjusted annually based on actual costs. Invoices are typically sent out in September of each year.

Per the *Policies and Procedures of the AVMA CVTEA*, documentation of progress toward compliance with critical and major deficiencies must be included in the program's report to CVTEA. Insufficient progress toward meeting deficiencies may be considered cause for change in the program's accreditation status.

If there are any changes that impact critical or major deficiencies that the CVTEA previously determined do not require continued reporting, the program must report this change.

4.	Documentation be provided that qualifications of applicants include an aptitude, interest, and understanding of a career in veterinary technology. (7b)	Unmet; report on any updates regarding this deficiency.
5.	Students complete the curriculum. (10a)	Unmet; report on the number of students who have completed the curriculum.

Outcomes be assessed using performance of graduates on the Veterinary Technician National Examination (VTNE), Programspecific surveys of graduates and their employers, and feedback from the advisory committee, and an analysis of the results of those assessments be used for continued Program improvement. (11a, 11b)	Unmet; when available, submit examples of completed graduate and employer surveys, VTNE score reports, and a summary of how outcomes data and advisory committee feedback are being used for program improvement.
NEW CONCERN	CVTEA noticed what appears to be fiberboard topped stools in the new laboratory area. Based on historical perspective this product is considered to be a safety concern as the fiberboard is not impervious to liquids or pathogens and cannot be properly sanitized.	A report on the status of the lab stools is requested with the next report to the CVTEA. Photographic or video images will be needed to further assess what the program is using for seating in the laboratory room.
