APPLICATION INFORMATION PACKET

The requirements, procedures, application dates, and program offerings for all Health Science programs are **subject to change.** It is the responsibility of each student to seek current information. Students interested in a nursing career should register to attend a nursing information workshop by calling the Ventura College Counseling Office at (805) 289-6448. **After attending a workshop**, interested students may schedule an appointment with a **nursing counselor**. Call (805) 289-6448.

The nursing program is approved by the California Board of Registered Nursing and has received national accreditation by the Accreditation Commission for Education in Nursing (ACEN). Offered is an Associate Degree in Nursing with a program of clinical components in which the student cares for patients in the acute care and community settings.

Upon completion of the Associate Degree program in Nursing, students will be eligible to take the NCLEX-RN examination leading to licensure as a Registered Nurse. The student must have fulfilled all requirements as defined by the California State Board of Registered Nursing. A licensed Registered Nurse (RN) may seek employment in an entry-level staff nurse position in a variety of health care settings.

Associate Degree Curriculum

The associate degree program in nursing is intended to develop the necessary knowledge and skills basic to the functions of registered nurses in the direct care of clients. Many of the courses assigned to this curriculum are transfer courses and articulation is possible with the baccalaureate programs in nursing at the California State University campuses and other private baccalaureate programs. The courses may be applied as a foundation for advanced work at the discretion of the accepting institution. Courses are taken on campus concurrently with supervised clinical experience in selected hospitals and agencies, constituting a nursing science practicum or laboratory experience. Each student is responsible for his/her own transportation to the extended campus sites, some of which are a distance from the College. Although each course merits a letter grade, the laboratory experience is based on pass-fail and it is necessary to pass the laboratory section of the course in order to proceed in nursing. Failure in the laboratory portion of a nursing course constitutes a failure in the course.

<u>ADMISSIONS REQUIREMENTS – the Nursing Program requires students to qualify and apply for admission:</u>

Prerequisite Requirements to Apply

These required prerequisites must be completed to be eligible to apply to the Nursing Program. Students must complete the prerequisite courses with a minimum letter grade of "C" to be eligible and considered for the Nursing Program. No prerequisite course/requirement may be in-progress when applying.

- 1. Intermediate Algebra level or any higher level math course
- 2. Chemistry V20 & 20L or V30 & 30L or higher level (5 semester units) with minimum grades of C, or one year of high school chemistry
 - a. Effective February 1-28th 2024 application cycle (for Fall 2024 admission) High school chemistry will no longer be accepted to fulfill the Nursing Prerequisite requirement. Students must complete a college chemistry course with a corresponding lab.
- 3. Anatomy V01 (4 semester units)
- 4. Physiology V01 (4 semester units)
- 5. Microbiology V01 (4 semester units)
 - a. Effective February 1-28th 2024 application cycle (for Fall 2024 admission) A seven year recency requirement for Anatomy, Physiology, Microbiology will be instituted for both Generic and Advanced Placement applicants.
- 6. Current California CNA Certification (or CA Psych Tech or CA LVN license) Active CNA certification is recommended to be maintained through the semester you are entering, but is not required. Certification is provided by the California Department of Public Health.

Science Requirements

Effective Fall 2005 and thereafter, the combined anatomy & physiology (ANPH V01) course no longer meets entrance requirements for the nursing program. If the combined course was completed prior to Fall 2005, it will be accepted for admission. All entering students will be required to have a minimum overall college GPA \geq 2.50 and an overall biological science GPA \geq 2.50 (anatomy, physiology, microbiology) with no more than one withdrawal, D or F in ANY of these three (3) courses.

Qualifying Requirements

In addition to completing the required prerequisite requirements listed above, students must also meet the following requirements:

- 1. Minimum 2.5 Overall GPA calculated from all regionally accredited colleges/universities attended/attempted official transcripts from each college/university must be on file with the Ventura College Admissions and Records Office.
- 2. Minimum 2.5 Science GPA calculated from grades in anatomy, physiology, and microbiology
- 3. No more than one repeat in the core biological sciences (anatomy, physiology, or microbiology)
- 4. Attainment of the "success score" (currently ≥ 62%) on the state mandated diagnostic assessment test, the Test of Essential Academic Skills (TEAS). The VC Nursing program uses the first attempt on ATI TEAS version 7 (subject to change). If not successful on the first attempt the student must remediate. The ATI TEAS exam can only be taken twice

maximum. The first successful ATI TEAS exam score will be used for the multi-criteria calculation.

TEAS Exam

Students who do not meet the mandated success score must schedule an appointment with a nursing counselor to discuss remediation and retesting requirements. The success score for the TEAS exam is subject to change based on the State Chancellor's requirements. If remediation is needed, the student must reapply to the nursing program after successful remediation. Results of testing at other sites are accepted when forwarded directly to Ventura College by the testing company. Tests completed at other sites are counted as testing attempts. Accommodations for testing may be available to students with disabilities. Applicants must notify the nursing program and obtain Education Assessment Center (EAC) authorization prior to scheduling a TEAS exam if accommodations are required.

Procedures for Applying

Applications are accepted twice yearly. Admission is subject to meeting the eligibility requirements and available openings. The Associate Degree Nursing (ADN) program is impacted and has a waiting list. Application and TEAS exam deadlines are as follows:

August 1st – August 31st (11:59pm PST) for Spring admission

February 1st – February 28th (11:59pm PST) for Fall admission

Applicants must have a valid VCCCD Student ID# to apply.

- 1. Complete all required prerequisites to apply and meet qualifying requirements.
- 2. Submit official transcripts from all regionally accredited colleges/universities attended regardless of the type of coursework completed.

Admission Process

The Nursing Program will admit a minimum of 50% of students based on enhanced admission criteria.

- 1. No new applicants will be added to the existing Nursing Waitlist.
- 2. The Nursing Program will screen and rank order all students on the wait list based on a multi-criteria screening.
- 3. Fifty percent (50%) of the students with the highest scores from the multi-criteria screening will be admitted FIRST to the nursing program.
- 4. Fifty percent (50%) of the entering class will be admitted based on their position on the wait list.

Enhanced criteria will include:

GPA in science courses, repeats on science courses (anatomy, physiology and microbiology), academic degrees, diplomas, or relevant certificates held by an applicant; relevant work or

volunteer experience, life experiences or special circumstances of the applicant, including but not necessarily limited to the following - disabilities, low family income, first generation of family to attend college, need to work, disadvantaged social or educational environment, difficult personal and family situations or circumstances, refugee or veterans status, proficiency or advanced level course work in languages other than English and assessment / readiness test results (TEAS scores). In each of the science courses, the FIRST passing grade is the one used to calculate the science GPA, even if the course was repeated and a higher grade earned.

Each qualified applicant, when selected, must decide to enter the class or decline admission or request a deferment. Deferment will not be an option for new applicants. New qualified applicants that decline admission or who are not selected for admission, **WILL NOT** be placed on a waitlist and must **reapply** again during the next application period. Please note that a new application must include all new documentation as any old documents will not be saved.

Additional Required Coursework

Additional courses required for those enrolled in the ADN program are listed below. With the exception of human development, students may complete these additional courses before or after acceptance into the nursing program. The School of Nursing recommends that students complete as many courses as possible before acceptance as scheduling may be a major problem once admitted to the program. Completion of these courses after completion of the nursing program delays the licensure examination. Students who delay taking the licensure examination have a significantly higher risk of not passing it. These Ventura College courses, listed with the comparable courses from Moorpark (MC) and Oxnard (OC) Colleges, are:

Growth & development across the lifespan: CDV 03 or PSY V05 (PSY M07 - MC; Psy R108 [Developmental Psychology] - OC)

- a. ENGL V01A (ENGL V02 or V03 not acceptable); (ENGL M01A or M01AH MC; ENGL R101 - OC)
- b. PSY V01 (PSY M01 MC; PSY R101 OC)
- c. ANTH V02 or SOC V01 or V02 or V03 OR AES V11 (ANTH M02 or SOC M01, M02, M08 MC; ANTH R102 or SOC R101, R102, R103 OC)
- d. COMM V01 (Introduction to Speech) or V10 (COMM M01 or M02 or M07 MC; COMM R101 OC).

Additional courses required by Ventura College for the AS degree are:

- a. Humanities 2 courses
 - 1 course in Fine or Performing Arts (see AA/AS Check Sheet)
 - 1 course in Humanities (see AA/AS Check Sheet)
- b. Physical Education / Health Education 2 courses (NS V40 fulfills one Health Education requirement for nursing majors only.)
- c. American History and Institutions 1 course (see AA/AS Check Sheet)

- d. Competency Requirements:
 - a. Reading satisfactory completion of degree requirements
 - b. Written expression satisfactory completion of ENGL V01A
 - Mathematics satisfactory completion of Intermediate Algebra or higher level math course – Recommended Math V44 Elementary Statistics (with or without Math V44J) or Higher level course in Mathematics

Upon Admission

After students have been selected to the Nursing Program, a physical exam must be passed prior to entry into the program. Physical exam requirements are consistent with the policies of the teaching hospitals or agencies to which students are assigned for clinical experience. Physical exams may be scheduled with a private physician or through the Student Health and Psychological Services utilizing the forms provided by the School of Nursing. The examination must demonstrate that the student is physically fit, free from communicable diseases and immune to rubella, rubeola, mumps, varicella and hepatitis. Current tetanus, diphtheria, pertussis (Tdap), Covid and Covid booster (if eligible), and influenza vaccination is required. The health care provider must verify that the student is able to participate the nursing program without physical restrictions. Tuberculosis (TB) clearance must be submitted by the posted deadline each semester to progress in the nursing program and may not expire during the semester. Two-step TB testing or QuantiFERON blood test is required.

All students admitted to a health science program are expected to maintain the highest personal standards for conduct consistent with the professional standards as perceived by the School of Nursing faculty and professional personnel in the agencies used as extended campus sites. Any information indicating that such standards are not maintained is subject to review by members of the School of Nursing faculty and may result in a recommendation to the College for dismissal from the program. Evidence of physical and emotional fitness upon admission and throughout the program is expected and is subject to medical opinion or policy of hospitals or agencies that are used as extended campus sites for assigned educational experience. Students should refer to the Technical Standards outlined in the School of Nursing Student Handbook for details. Current CPR certification for basic life support provider or basic life support for healthcare provider is an additional requirement and must be submitted each semester by the posted deadline to progress in the nursing program. Online CPR courses do not fulfill this requirement. Certification may not expire during the semester.

Background Checks / Drug & Alcohol Screening

Please be aware that conviction of a felony may prohibit you from being licensed as a registered nurse. Each case is reviewed and adjudicated by the board of registered nursing. The board considers the nature and severity of the offense, additional subsequent acts, recency of acts or crimes, compliance with sanctions, and evidence of rehabilitation. For further information, contact the program director in the school of nursing or a nursing counselor. Contact with the board of registered nursing to discuss previous convictions may be initiated before entry into the program and this will be recommended in certain cases.

Students in the nursing program are required to undergo criminal background checks prior to participating in clinical experiences. The cost of a background check is approximately \$60.00 and must be borne by the student. Background checks for admission to the nursing program involve a seven-year search. Misdemeanors and / or felonies within the previous seven years (including DUIs) will result in a student's inability to be assigned to a clinical agency for patient care experiences. This will necessitate dismissal from the program.

Applicants will be required to pass drug and alcohol screening prior to entering the nursing program. This is a requirement of the clinical agency partners. Students with a positive drug or alcohol screen will be immediately disqualified for admission. The drug and alcohol screening may only be done one time and these results are used to determine eligibility. The Ventura College School of Nursing does not permit students to be under the influence of alcohol, marijuana, or other drugs while attending the nursing program; either medically prescribed or otherwise. The School of Nursing complies with the United States Code Controlled Substances Act, Title 21, Chapter 13, Drug Abuse prevention and Control. Students already enrolled will be required to pass a drug and alcohol screening to progress in the program. Costs for this testing must be borne by the student and currently is approximately \$50.00.

BRN Statement on Legalized Marijuana

Statement from the California Board of Registered Nursing. This can be found on page 22 of the BRN Annual Report published November 2017:

"BRN's mission is to protect and advocate for the health and safety of the public by ensuring the highest quality registered nurses in the state of California. RNs are expected to be cognitively, mentally, and physically intact in their personal and professional lives. Russell and Beaver (2013) * expressed that professionalism extends beyond the workplace and that all RNs are obligated to be professional in all aspects of their lives. A person who holds an RN license has a responsibility and obligation to ensure public safety. Drugs such as cannabis (aka marijuana), opioids, and alcohol may impair an RN's ability to make decisions that may affect the life and safety of the public and have negative outcomes. This action constitutes conduct that would be considered unprofessional nursing practice."

"Although medical and recreational cannabis may be legal in California, the federal government considers cannabis a schedule I controlled substance."

SOCIAL SECURITY CARD/ITIN: Applicants should be aware that a valid Social Security or ITIN number will be required to be presented to complete the mandatory background checks.

Competency Requirements must be met in the following areas: Reading, Written Expression, and Mathematics.

Current CNA Certification is required for admission into the nursing program. Students who do not have <u>current</u> certification when they submit their application for admission into the nursing program will not be eligible for admission.

Highly Recommended Courses although not required, it is strongly recommended that the following courses be taken prior to admission to the ADN program: NS V07 Pharmacology (3 units) and Bus V27A.

Major requirements for transfer students in this field and related disciplines differ from associate degree requirements; if you plan to transfer, consult your counselor.

The combined anatomy/physiology class (ANPH V01) is accepted as the ADN A&P prerequisite if it was taken prior to Fall 2005.
