Thank you for all the work you put into completing your comprehensive program review. It has been reviewed by the College Planning Committee and the Executive Team. The College Planning Committee feedback is attached. Below, you will find comments, commendations, and recommendations from the Executive Team. Commendations:

1. Impressive manner in which the program aligns with the Mission of the College.
2. Students using the Child Development Center as a learning laboratory have the opportunity to complete hands-on fieldwork and observation assignments needed to build job skills leading directly to employment as well as course completion, acquisition of CTC permits, and the completion of degrees and certificates and transfer.
3. Renewal of U.S. Department of Education CCAMPIS grant, the program will be able to provide 100% child care scholarships for full time students and (a prorated percentage for students enrolled in less units) to students who meet the financial aid qualifier through September 2023.

Ventura College will be a beacon of learning — a source of inspiration and guidance — for our students and community.

Recommendations:

1. Further build collaborations with various student services programs for College's outreach initiatives such as First Year Experience, Basic Needs, Pirate Days when high school students visit campus so that new and prospective Ventura College students know about all available services.
2. Continue to work with FMO, Administrative and Business Services, as well as, our Risk Management Consultant to evaluate and improve the safety of the center.
3. Expand marketing efforts to ensure that the Child Development Center is fully enrolled to meet community needs.

CPC's overall recommendation is to strengthen the program to which I concur. Thank you again for your dedicated work in improving outcomes for our students.

The program is working to make program improvements in order to increase student success and quality of education.

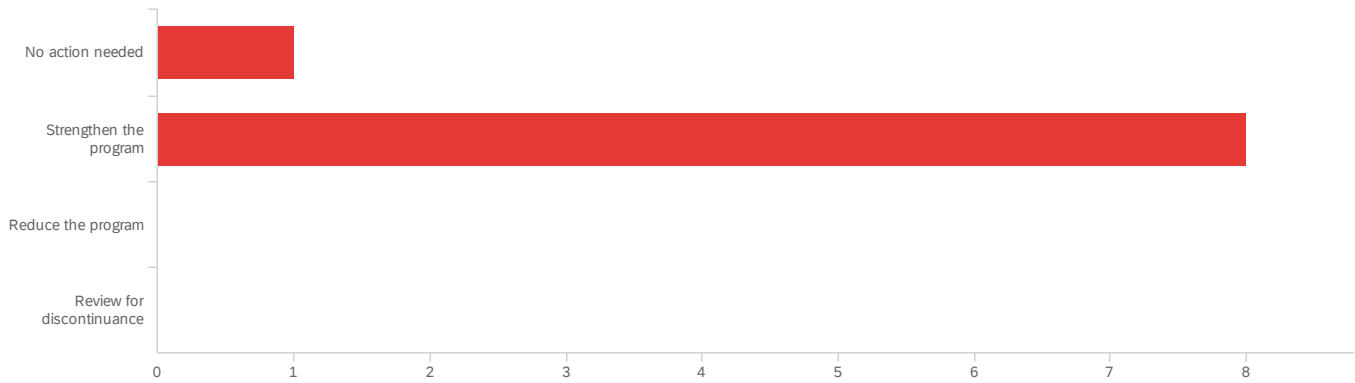
The program objectives align with the Educational Master Plan as the objectives are working towards creating safety improvements and increasing availability of services for the community.
