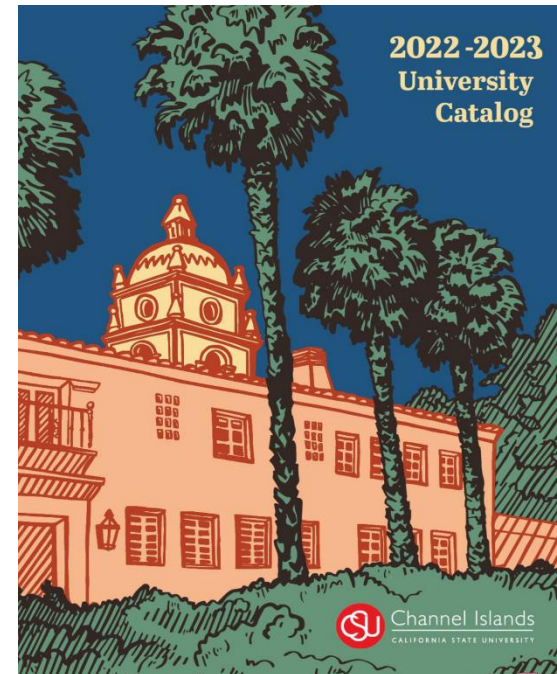

Admission Requirements

To be considered for transfer, students must:

- ✓ GPA of 2.0* or better
- ✓ 60 semester units
- ✓ GE units for transfer
- ✓ Golden four with grades C or better
 - ✓ Oral communication
 - ✓ English writing
 - ✓ Critical thinking
 - ✓ Quantitative Reasoning
- ✓ No AA/AS requirement

Mandatory Lower Division Prerequisites (Grade C or better)

- ✓ Introduction to Psychology (required to be completed by end of spring semester).
- ✓ Statistics (required to be completed by end of spring semester).
- ✓ Developmental Psychology*
 - * Students may be eligible for “provisional admission” and complete this class at another institution while concurrently enrolled in CSUCI’s BA-Psychology (by end of fall 2023 semester--).

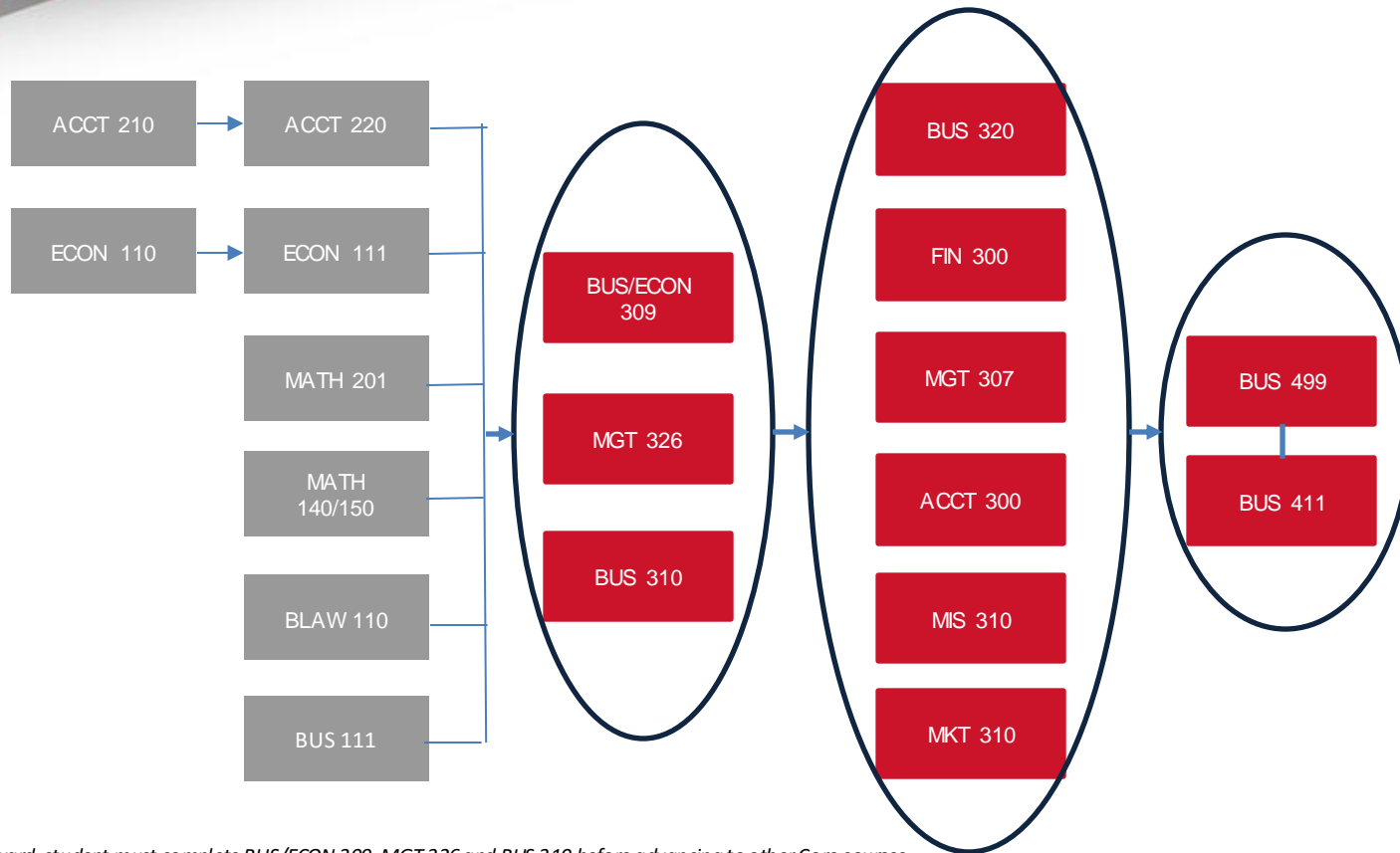

What's that mean for BUS majors?

A

- The optimal path to transfer
- Associate degree with Statistics & Calculus also good!

D

- Lower-division requirements can hold you up, GE courses (generally) won't
- Coming in without lower-division core adds money and time to your degree path!

T

- Don't avoid the math courses; they are required for admission!

What lies ahead?

11	Upper Division Business Core	● Students complete a total of 11 upper-division major requirements (31 units)

- › Additional lower division requirements may be required for degree completion NOT program admission i.e., *language requirement and Title V: History & Govt.*
- › Area F: Ethnic Studies: if students have categories "A-E" completed, then Area F is not required.
 - maintained continuous enrollment at CC or CSU (at least one semester or two quarters each calendar year), **OR**
 - Fully GE certified, **OR**
 - Fully IGETC certified, **OR**
 - ADT awarded

ADMISSION REQUIREMENTS

UNIVERSITY REQUIREMENTS

- › Online application (www.calstate.edu/apply) & \$70 fee
(*Select intended major as Business Completion Program Online*)
- › GPA of 2.0 or higher
- › Transfer a minimum of 60 semester/90 quarter units for admission
- › Golder Four* (A1, A2, A3, B4) classes completed with grades of “C”- or better
- › Good standing (i.e., eligible to re-enroll) at last institution attended

PROGRAM REQUIREMENTS

- › Mandatory **lower division business prerequisites** to be completed prior to semester of admission:
 - Calculus
 - Statistics
 - Macroeconomics
 - Microeconomics
 - Financial accounting
 - Managerial accounting
 - **Introduction to Business Writing**
- › One set of official transcripts from every college or university attended
- › One set of official AP scores from College Board, if applicable

* Transfer students may earn general education or lower-division major credits by taking a CSU-accepted external examination such as Advanced Placement (AP), International Baccalaureate (IB), and College-Level Examination Program (CLEP).

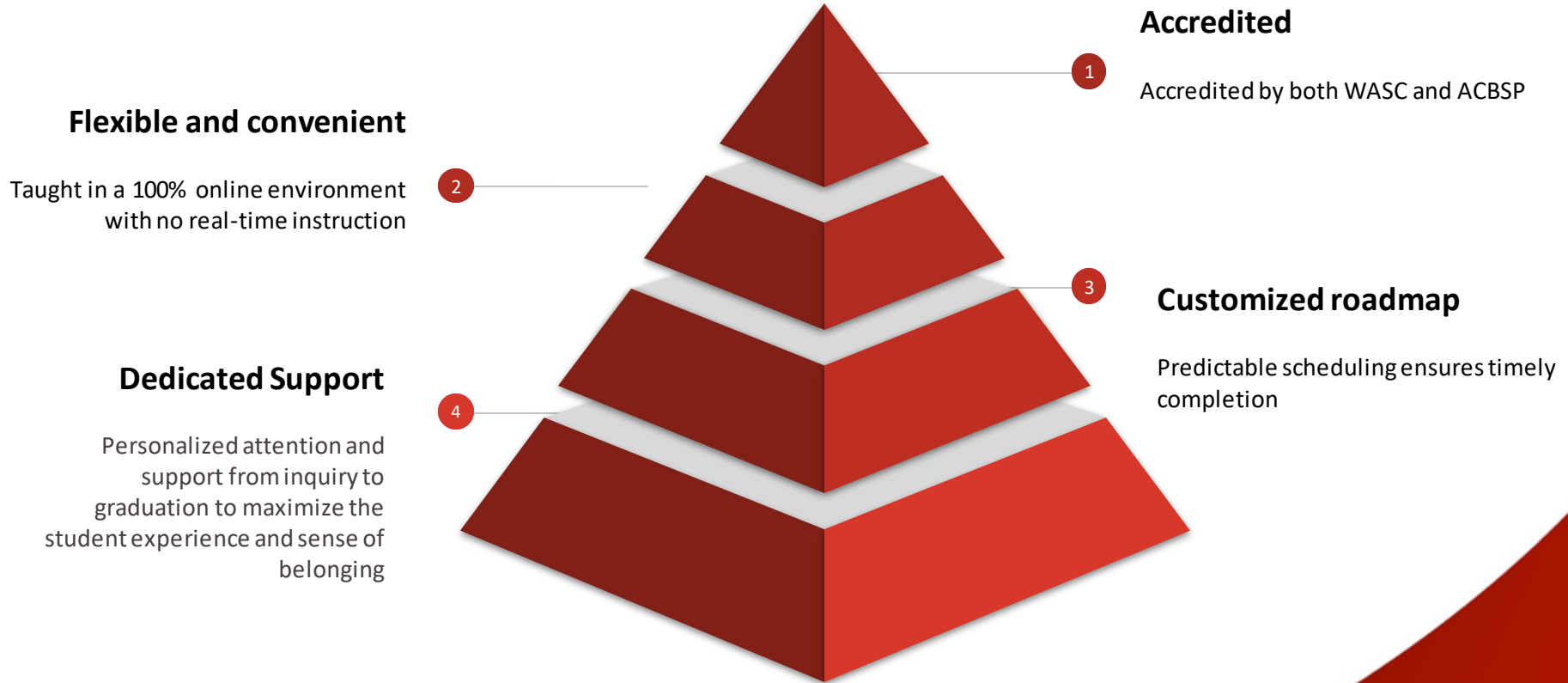

CPL: What and why?



CPL Project Goals

- Share information about the benefits of CPL/PLA (for students and for the institution) with VC faculty.
- Help faculty access CPL resources and develop CPL evaluation procedures.
- Assure faculty that they will be compensated for the time they spend evaluating CPL applicants.

What is CPL/PLA?

- CPL or PLA are terms for various methods that colleges, universities, and other education providers use to evaluate **learning** that has occurred outside of the traditional academic environment.
- It is used to grant college credit, certification, or advanced standing toward further education or training.

What CPL/PLA is not

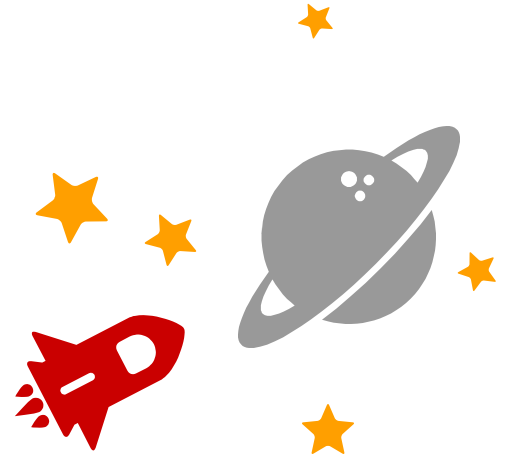
- The CPL/PLA process emphasizes reflection, which empowers individuals to think deeply about their previous experiences, as evidence of learning.
- It therefore awards college credit for learning, but does not award credit for mere experience.

Why CPL/PLA? In a word...

Equity!

Equity is the driving force behind CPL/PLA. Recent studies show that Black and lower-income adult students received strong boosts to completion from being awarded CPL/PLA—but, paradoxically, were the *least likely to receive such credit*.

More reasons why...for students...

- Saves students time and money.
- More adults graduate and key groups benefit.
- Empowers adult learners by validating them as learners.

More reasons why...for the college...

- CPL is a proven tool for boosting students' chances of completing a degree (i.e., more students graduate).
- The opportunity to earn CPL has a powerful influence on a prospective student's choice of college.
- Students who earn CPL credits are more likely to enroll in additional credits.

More reasons why... for legal/regulatory compliance...

- Ed Code §66025.71 requires CCCs to evaluate work of students holding a JST.
- Title 5 §55050(a) requires CCC districts to adopt policies whose effect is to allow students to attain credit for prior learning.
- AP 4235 (formerly the Credit by Exam procedure) has undergone revision to address the CPL modalities listed in Title 5.

2. CPL Modalities/Credit

External examinations

Including (but not limited to) AP, IB, CLEP



Departmental exams

Representative collection of relevant work

Key considerations for awarding credit

- The educational quality of the acquired learning for which the student seeks CPL.
- Comparable content, scope, and rigor of the acquired learning to that offered by VC.
- Appropriateness/applicability of the learning experience toward completion of a VC program (degree or certificate).

CPL/PLA evaluation: first steps

- For external exams (AP, IB, CLEP), the student asks a counselor for evaluation on the basis of the cut scores published in the catalog.
- For HS articulation, the HS teacher enters the student's course grade into CATEMA.
- For other CPL modalities, the student submits a district petition to request CPL evaluation.

Career And Technology Education Management Application (CATEMA®)

- CATEMA is a web application designed to provide a simple method to enter, update, display, and report course articulation outcomes and Career and Technology Education related information.
- Students must create an account in CATEMA before requesting HS articulation credit.

CPL/PLA evaluation: next steps

- Students completing the CPL petition will meet with faculty, who state the expectations/criteria for the evaluation (e.g., what score a student must earn on an exam, or what to include in a portfolio).
- Student completes exam or submits documentation, as applicable.
- Faculty decide whether to award credit.

How is credit recorded?

- CPL transcription must clearly indicate the credit was awarded after an assessment of prior learning (see Title 5 § 55050(f) and AP 4235; a sample VCCCD transcript showing CPL appears on the next slide).
- Depending on the evaluation modality, students may earn elective credit, GE credit, or credit for a specific VC course (see AP 4235 for details).
- The evaluating faculty member assigns letter grades (or P/NP if available) to any student seeking to earn **course** credit via CPL.

3. How will CPL affect me?

Will CPL impact my work life? Will I be paid for participating in CPL evaluation?

Impact on faculty

- Will I be overwhelmed?
 - Probably not; the “**floodgates**” opened two years ago, when Title 5 started to require the awarding of CPL to qualified students. So far, the college has seen only a **trickle** of students applying for CPL.
- Will I be paid?
 - VC management has committed to **compensating faculty** for CPL evaluation work; details are still being worked out.

4. Next steps

What does our department or division need to do?



1. Evaluate course inventory

Should CPL be awarded for this course? (Probably!)



2. Build an evaluation process

I will be coaching faculty on how to do this.



3. Assess prior learning

Start awarding CPL to qualified applicants!

Course inventory evaluation

- All courses in your discipline(s) will be CPL-eligible unless explicitly designated otherwise.
 - A&R will maintain a master list of courses not designated as eligible. Our goal is for this to be a very short list.
- The host discipline or department for a CPL-eligible course needs to determine the evaluation modalities it will consider.
 - Ideally all modalities should be accepted, but there may be a few courses for which certain modalities might not work.

Building the evaluation process

Who?

To whom will CPL requests be delegated?

Who determines the nature and content of the assessment?

How?

Is it a committee or an individual who performs the evaluation?

Does the department chair need to sign off?

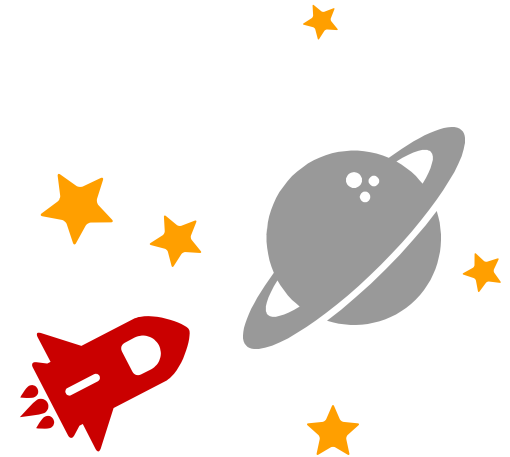
What?

Is a rubric needed to fairly evaluate student portfolios?

Should the department review the cut scores for standardized tests in its discipline(s)?

Idea

Big Picture of Remedial Education Reform

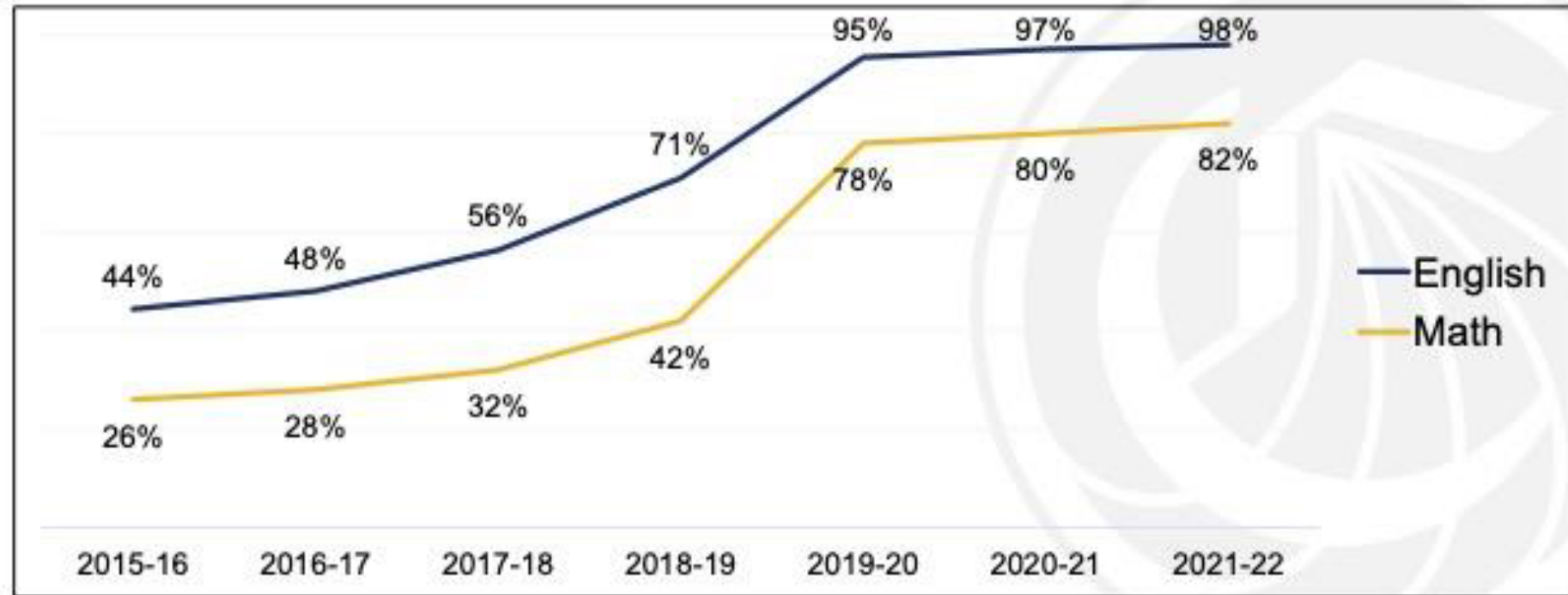
- Transformative changes statewide and at Ventura College

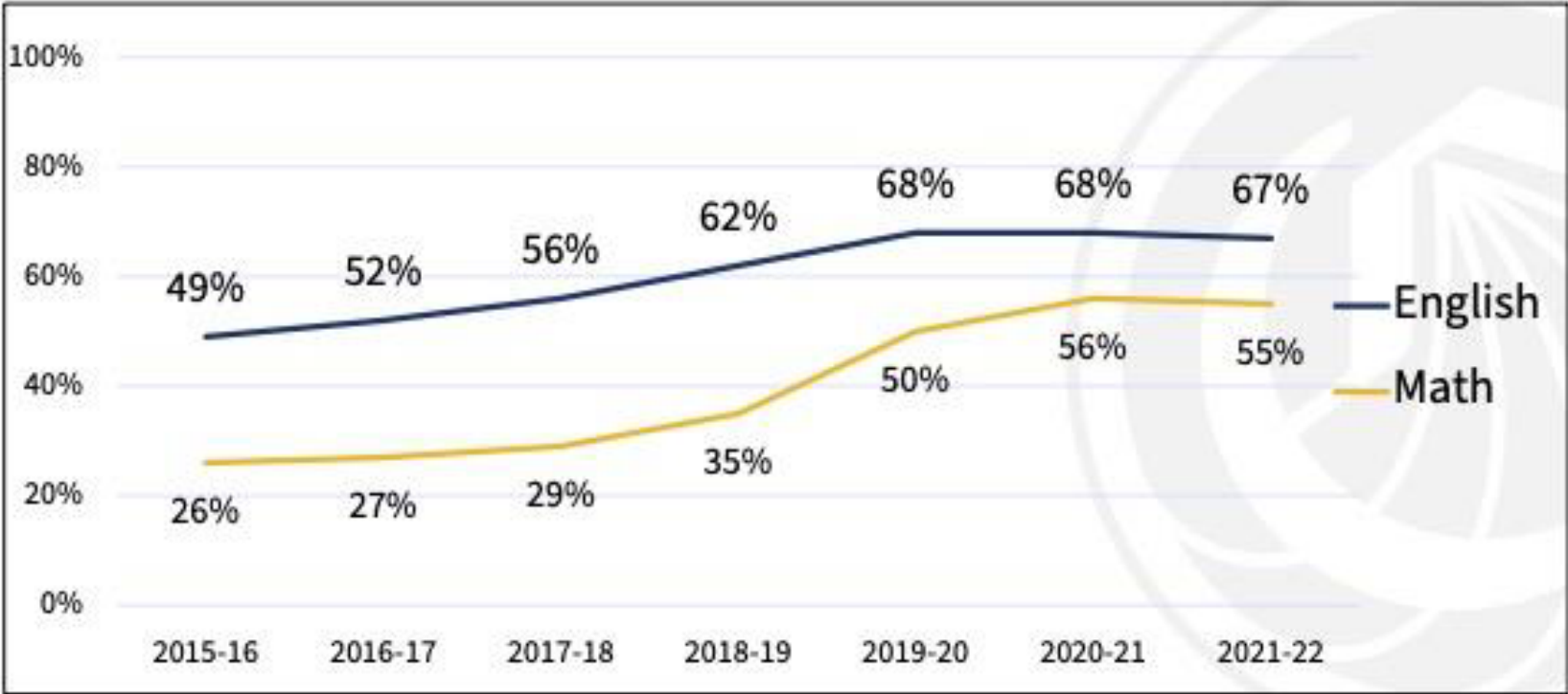

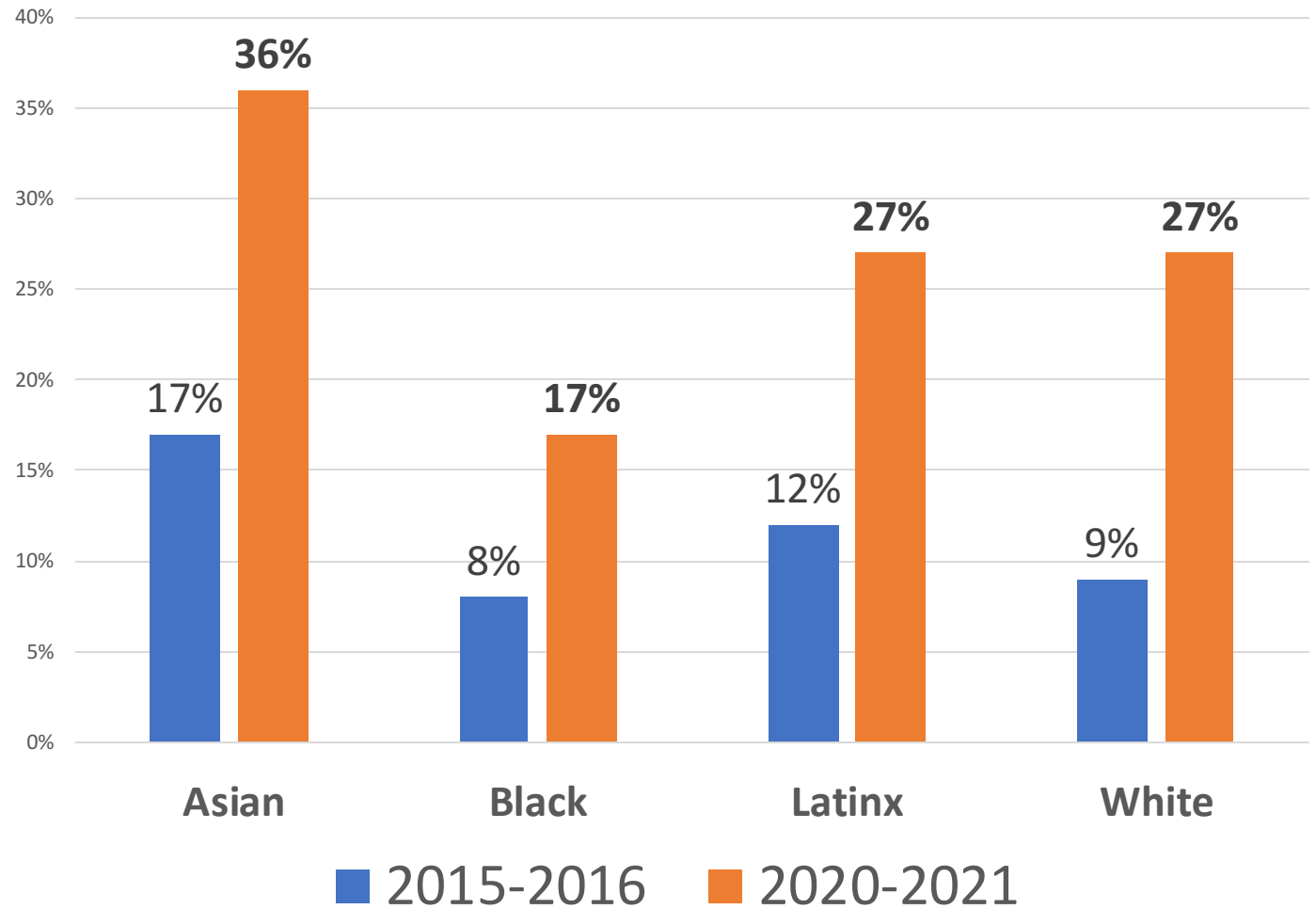

 - For all other students, it increases their likelihood to transfer by 360%.

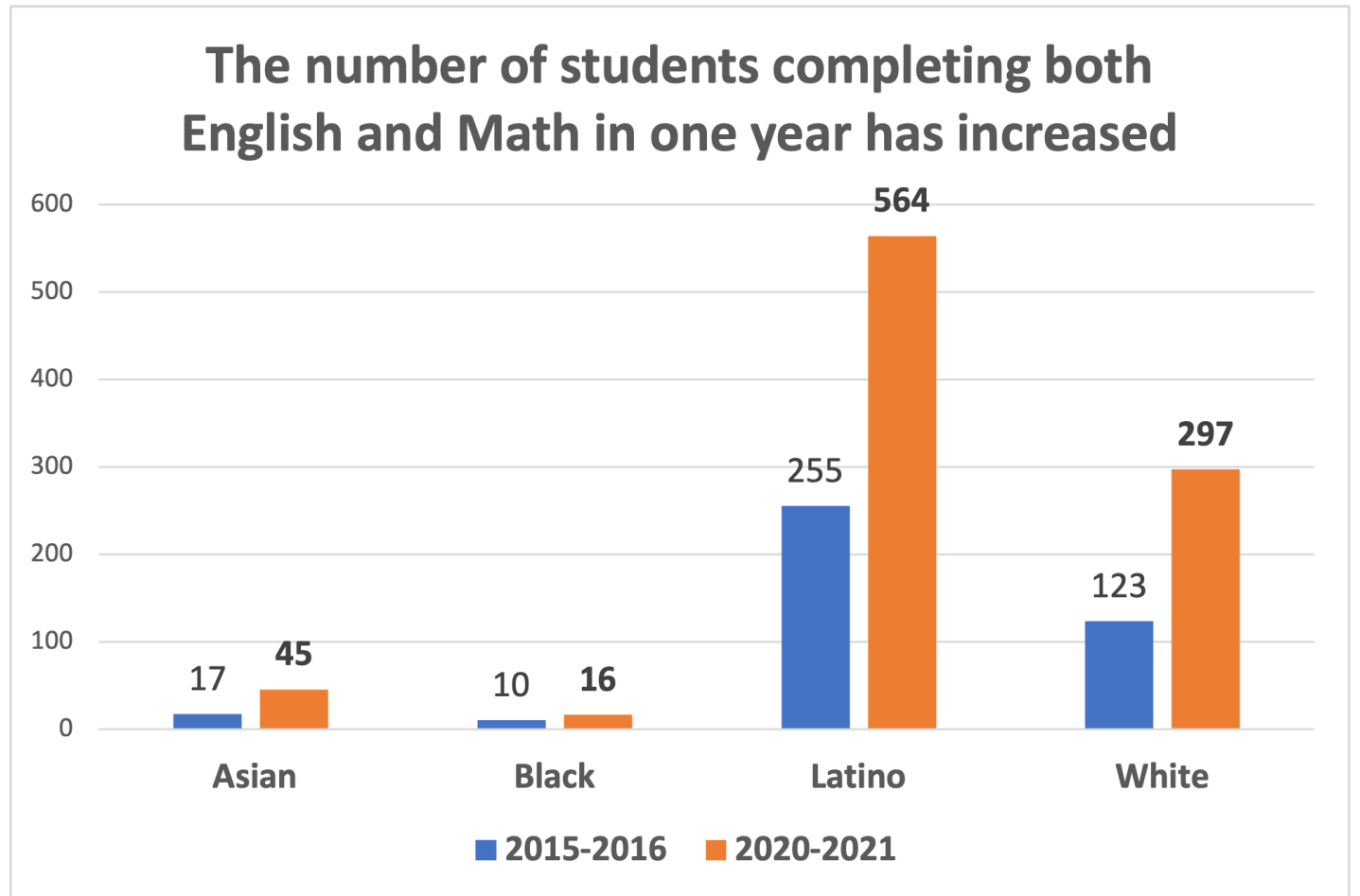

At Ventura, completion rates have more than doubled.

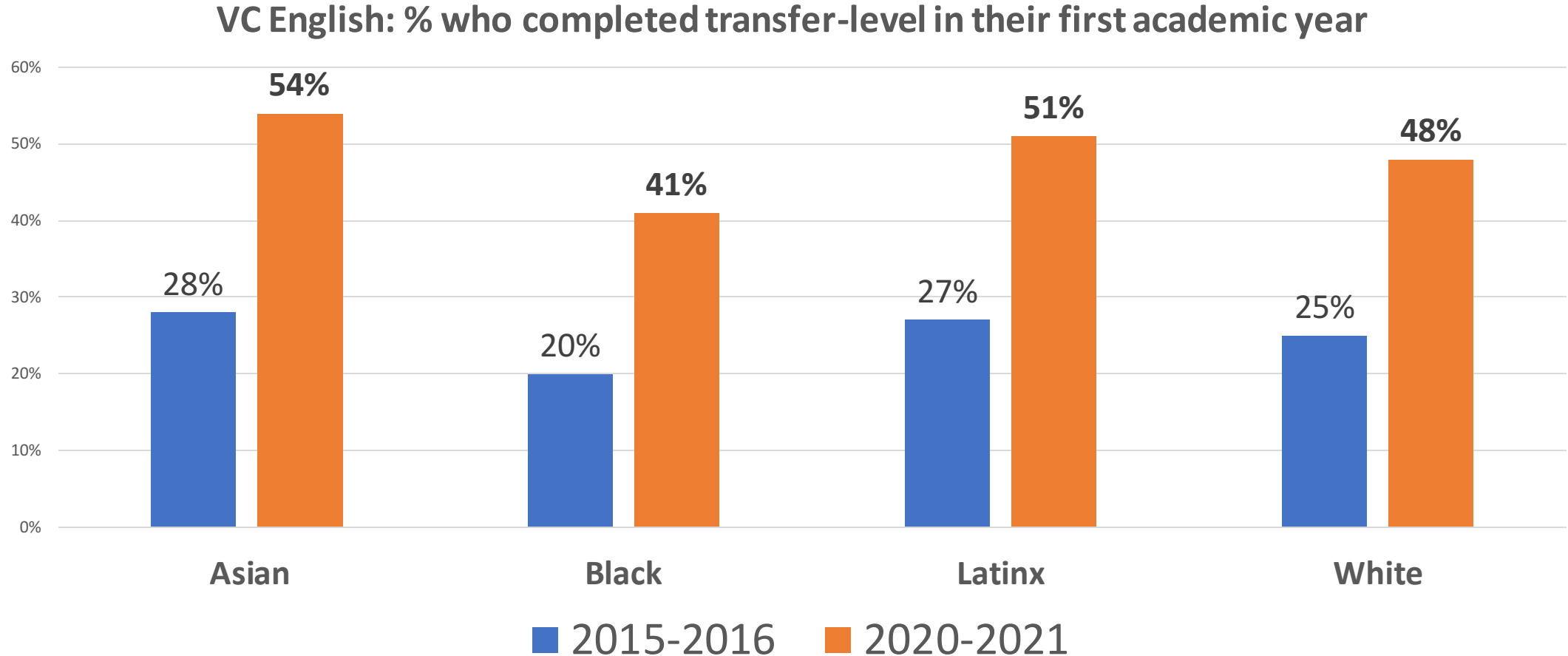
VC English & Math: % who completed transfer-level in their first academic year

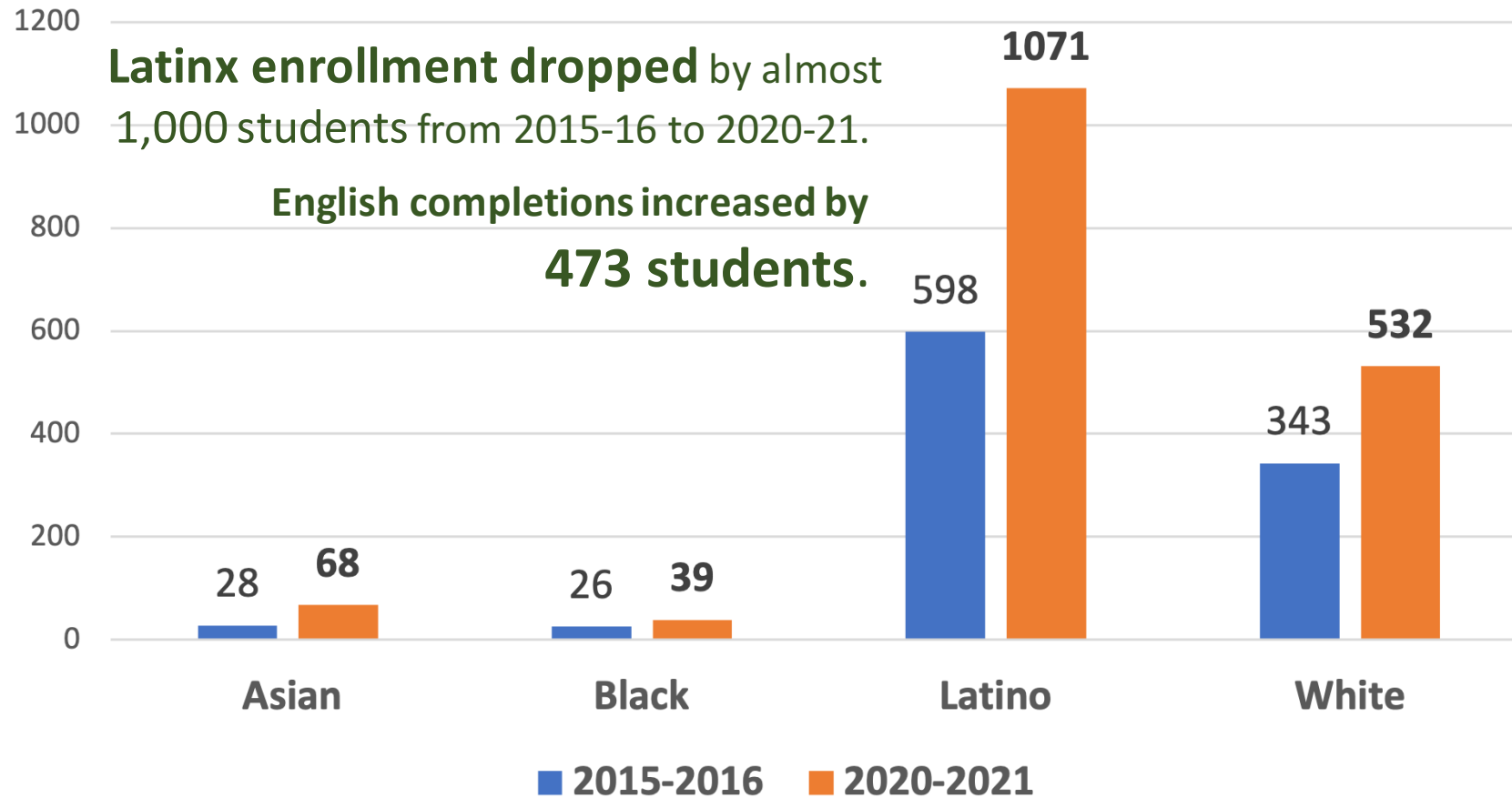


Impact of Open-Access English 1A



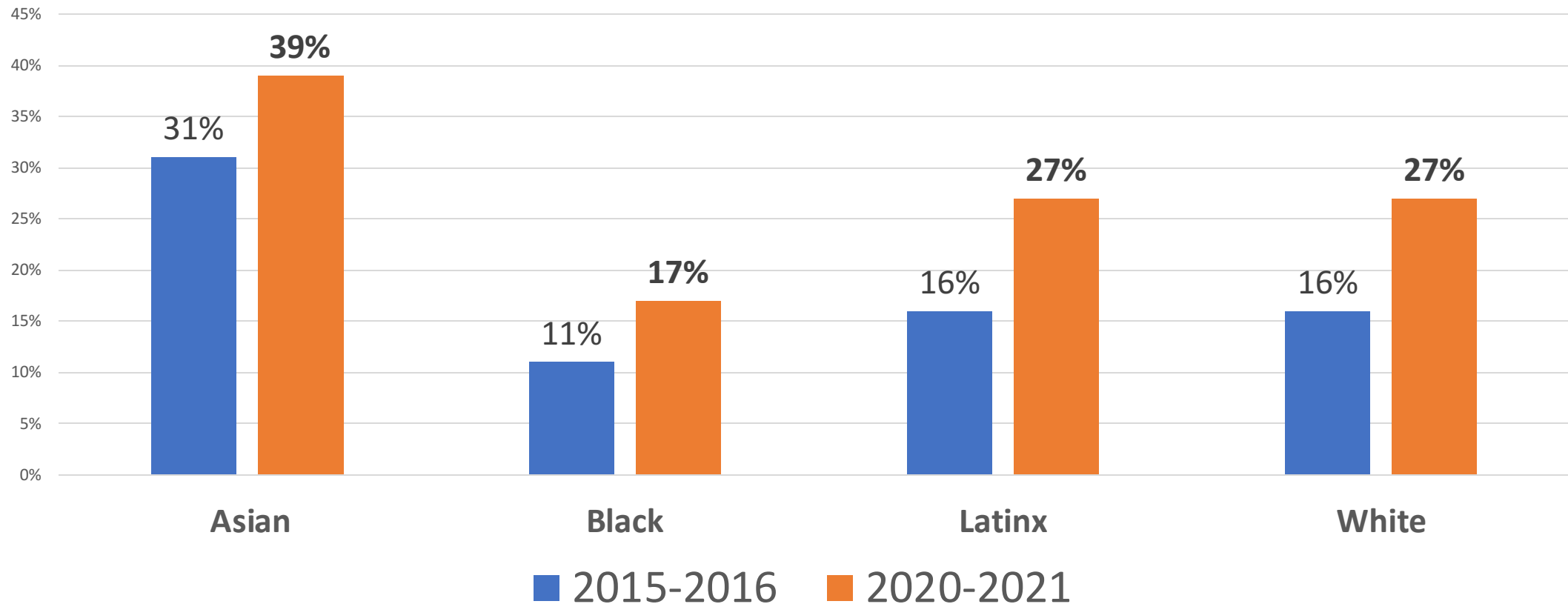

The number completing English increased most dramatically for Latinx Students.



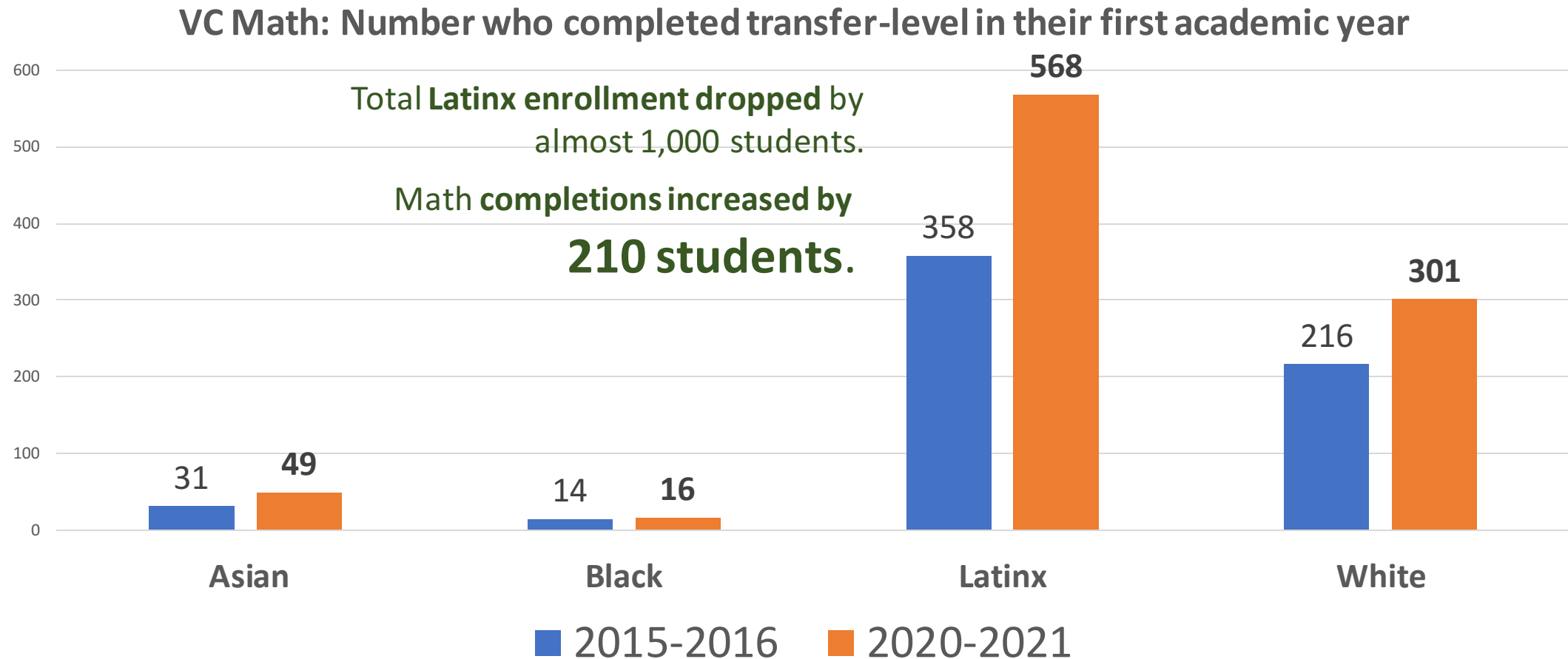
Students with first time Math enrollment and successfully completed any transfer level math course within one year

VC Math: % who completed transfer-level in their first academic year



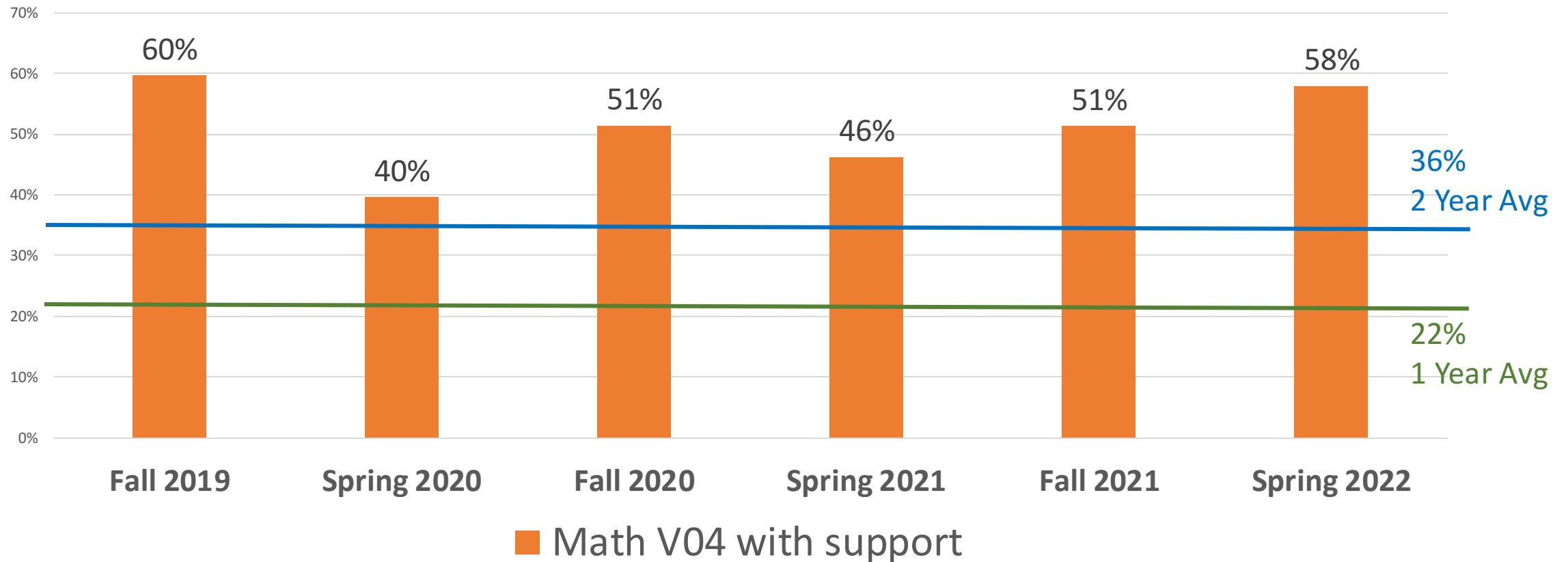

The number of students completing transfer-level math has increased, especially for LatinX

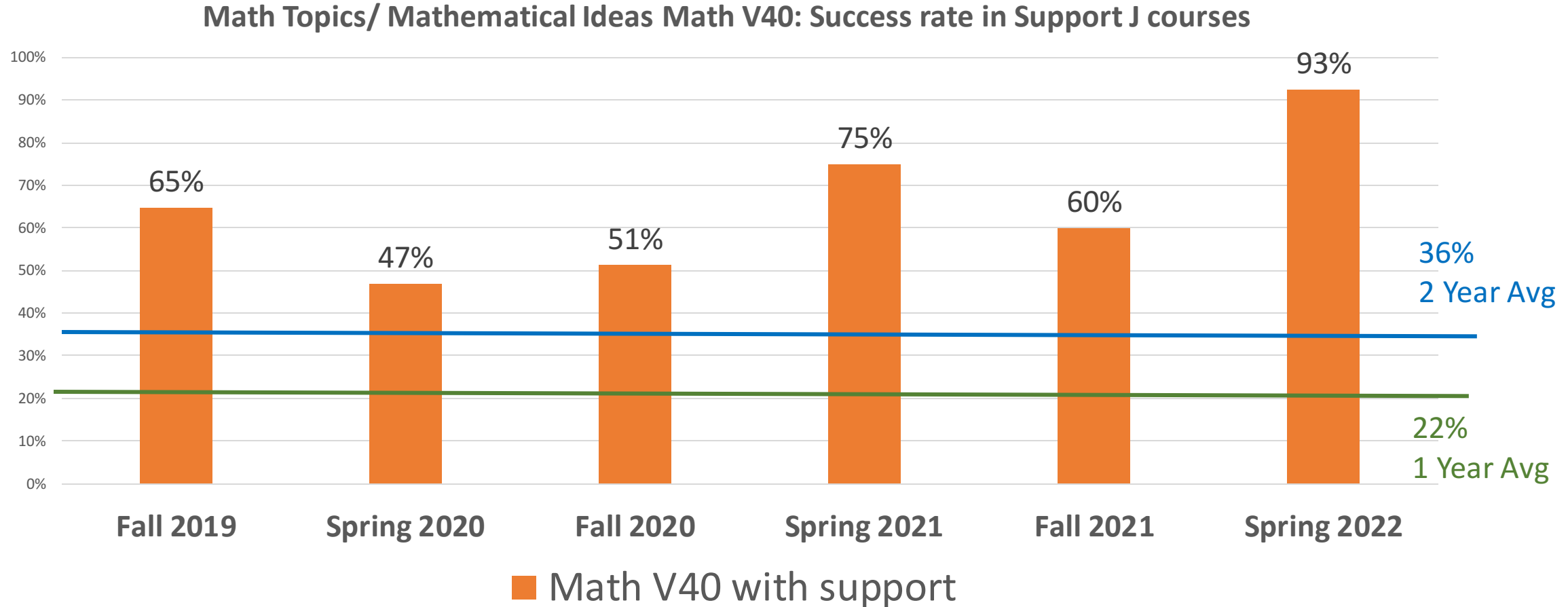


Math V04 One-Semester Success with Support vs. Average One-Level-Below Success (pre-AB705)

College Algebra Math V04: Success rate in Support J courses

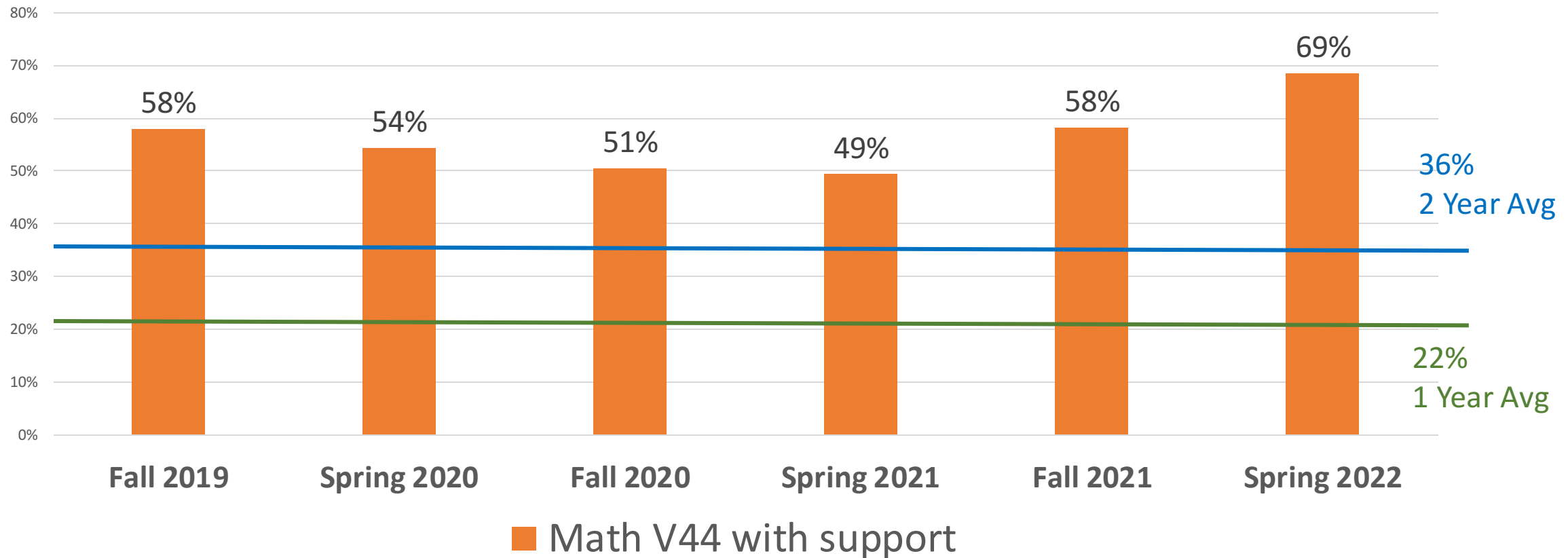


Math V40 One-Semester Success with Support vs. Average One-Level-Below Success (pre-AB705)

- Only 1 in 5 students (19%) passed English 1A by fall 2020.
