It has been a crazy time. Below is what we wrote in our program review for Fall 2020 - Summer 2021 (This does not include Spring 2020) for Ventura:

Hosted 61 training sessions with 1329 faculty and staff in attendance. Sessions range from 45-minute sessions to 4-week certification. Provide 6-8 hours per week of individualized just-in-time support per Instructional Designer via weekly Office hours, Open Studio workshops, and live sessions for the Online Teacher Training Course in Canvas (VCCCD Online Teaching Certification), Managing Faculty Help Desk (Mon-Fri 8-5 pm).
