Q4. Why was this request not included in the annual program review process?

This was not included in the annual program review process due to the sudden resignation of the tenure track faculty in this area occurring October 31, 2023.

Q17. Why is this request needed at this time (as opposed to going through the annual program review process)? Please describe how your program will be impacted if this request is not approved.

In order to support students in meeting their Ethnic Studies requirement for Cal IGETC this out of cycle request is needed. The new necessity for full-time faculty in Ethnic Studies cannot be understate as it has become a requirement for students pursuing an ADT.

In fact, the loss of this faculty member puts the department's goal reaching the required faculty necessary to instruct this discipline in jeopardy and will set students back in their educational goals.

The discipline's goals are faculty members in the 4 major areas of Ethnic Studies:

- 1 full-time faculty member to develop and teach Africana (African-American) Studies courses
- 1 full-time faculty member to develop and teach Native American Studies courses
- 1 full-time faculty member to develop and teach Asian American Studies courses
- 1 full-time faculty member to teach Chicana/Chicano Studies courses

The discipline was on its way to meeting 2 of the necessary hires, but with the resignation of the faculty member focused on Chicano/Chicana Studies the set back to the discipline and student access to courses cannot be understated.

In 2019-20 there were 92 VC students enrolled in Ethnic Studies and in 2022-2023 there were 619 enrolled. Since Ethnic Studies has been added to the Cal IGETC requirement for graduation in AB 928, it is clear that the number of students enrolling in these courses will only continue to increase. Since our incoming freshmen will be required to complete one course that meets the Cal IGETC Ethnic Studies graduation requirement this will cause an increase in the demand for Ethnic Studies courses and since Ethnic Studies is reading and writing intensive discipline, the class sizes will require similar enrollment to ENGL V01. This will make it impossible for VC to meet the needs of our students without growing our course offerings and our full-time faculty. Finally, due to the resignation of the tenure track faculty in this area there is currently only have 1 full-time instructor who teaches Ethnic Studies courses that meet this requirement.
