Proposed schedule:

1. The Call for artist designs should go out no later than February 2nd and be advertised to all of the major groups in Ventura County. I believe Sharla has a list.

2. This will allow us to close the design applications right after Spring Break – April 12

3. A committee should be formed to evaluate the designs – this could be done between February 5 and March 22nd.

4. The committee could meet for organizational procedures the week of April 8th.

5. The committee's selection could then be completed by April 26th and the necessary documents could go out for signatures/approval to the necessary groups.

6. This structure could see all of the necessary actions completed before the end of the Spring semester.

7. Lastly, the down payment to Muralism.org (\$5,000) for painting to begin in October should be paid by no later than March 1st. This will ensure they are available to execute the selected design.

## Q4. Why was this request not included in the annual program review process?

This request was not included in the annual program review process as it relates to the 100th anniversary of the College. It was assumed at the time that there was a committee that would approve this request and forward this project to the executive committee. The Art Mural Project was signed off on by Facilities and Operations Group (FOG) and a presentation was given on December 20, 2023, to the Executive Team of Ventura College by Interim Dean Ronald Mules about the details and requirements necessary to complete this project.

Q17. Why is this request needed at this time (as opposed to going through the annual program review process)? Please describe how your program will be impacted if this request is not approved.

This request is vitally important as it directly relates to the celebration of Ventura College's 100th anniversary which will take place in 2025.

The Mural Project being completed by October 2024 (see timeline above) could be used not only to celebrate the College in 2025, but as a promotional marketing tool to advertise the College its students, programs, and activities.
